4 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY 6 FORWARD - RESEARCH AND COMMERCIALIZATION PROGRAM. The Arkansas Science and 7 Technology Authority is authorized to carry forward an amount of up to 8 \$150,000 of any obligated but unexpended funds and appropriation in the Research and Commercialization Program for basic or applied research grants 9 10 which remains at the end of the first year of the biennium to be used for the 11 same purpose in the second year of the biennium. The provisions of this section shall be in effect only from July 1, 2005 through June 30, 2007. 12 13

14 SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 15 by this act shall be limited to the appropriation for such agency and funds 16 made available by law for the support of such appropriations; and the 17 restrictions of the State Procurement Law, the General Accounting and 18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 19 Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by 20 21 the Department of Finance and Administration, as authorized by law, shall be 22 strictly complied with in disbursement of said funds.

24 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General Assembly 25 that any funds disbursed under the authority of the appropriations contained 26 in this act shall be in compliance with the stated reasons for which this act 27 was adopted, as evidenced by the Agency Requests, Executive Recommendations 28 and Legislative Recommendations contained in the budget manuals prepared by 29 the Department of Finance and Administration, letters, or summarized oral 30 testimony in the official minutes of the Arkansas Legislative Council or 31 Joint Budget Committee which relate to its passage and adoption.

33 SECTION 9. EMERGENCY CLAUSE. It is found and determined by the General

34 Assembly, that the Constitution of the State of Arkansas prohibits the

35 appropriation of funds for more than a two (2) year period; that the

36 <u>effectiveness of this Act on July 1, 2005 is essential to the operation of</u>
