22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code § 6-21-711 is amended to read as follows:

25 6-21-711. Advisory committee – Members – Duties.

26 (a) There ~~are~~ is hereby established a Public Elementary and Secondary
27 School Insurance Program and a Public School Motor Vehicle Insurance Program
28 Advisory Committee, consisting of five (5) members as follows:

29 (1) The Chair and ~~Cochair~~ Vice chair of the Senate Committee on
30 Insurance and Commerce;

31 (2) The Chair and ~~Cochair~~ Vice chair of the House Committee on
32 Insurance and Commerce; and

33 (3) The Director of the Department of Finance and
34 Administration, or his or her designee.

35 (b) The committee shall meet at such times and places as it shall deem
36 necessary for the purpose of carrying out its duties under the provisions of



1 this subchapter.

2 (c) The committee shall select one (1) of its members as chair and
3 such other officers as may be deemed necessary for transaction of business.

4 (d) A majority of the members of the committee shall constitute a
5 quorum for the purpose of transacting business.

6 (e) All action of the committee shall be by a majority vote of the
7 full membership of the committee.

8 (f) Members shall serve without pay but may receive expense
9 reimbursement in accordance with § 25-16-901 et seq.

10 (g) The committee shall periodically review the status of the Public
11 Elementary and Secondary School Insurance Fund and the School Vehicle
12 Insurance Reserve Trust Fund.

13 (h) The committee shall perform such other duties in an advisory
14 capacity to the State Insurance Department as will expedite the operation of
15 the programs.

16 (i) All proposed procedures, guidelines, and other recommendations
17 pertaining to the programs recommended by the committee under this subchapter
18 shall be advisory to the State Insurance Department.
