## For An Act To Be Entitled

11 AN ACT TO AMEND THE PENALTIES FOR VIOLATIONS OF  
12 THE LITTER CONTROL ACT TO ALLOW FOR THE  
13 IMPOSITION OF A FINE AND TO REMOVE THE OPTION FOR  
14 JAIL TIME; AND FOR OTHER PURPOSES.

## Subtitle

17 TO AMEND THE PENALTIES FOR VIOLATIONS OF  
18 THE LITTER CONTROL ACT.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Arkansas Code § 8-6-404(a)(1), regarding penalties imposed  
24 for violations of the Litter Control Act, is amended to read as follows:

25 (a)(1)(A)(i) ~~Every~~ A person convicted of a violation of § 8-6-406 or §  
26 8-6-407 for a first offense shall be guilty of+

27 ~~(A) An unclassified misdemeanor for a first offense and~~  
28 ~~shall be fined one hundred dollars (\$100) and sentenced to eight (8) hours of~~  
29 ~~community service; and~~

30 ~~(B) A Class A misdemeanor for a second or subsequent~~  
31 ~~offense occurring within three (3) years of the first offense, an~~  
32 unclassified misdemeanor and shall be fined in an amount of not less than one  
33 hundred dollars (\$100) and not more than one thousand dollars (\$1,000).

34 (ii) An additional sentence of not more than eight  
35 (8) hours of community service shall be imposed under this subdivision  
36 (a)(1)(A).



1                   (B)(i) A person convicted of a violation of § 8-6-406 or §  
2 8-6-407 for a second or subsequent offense within three (3) years of the  
3 first offense shall be guilty of an unclassified misdemeanor and shall be  
4 fined in an amount of not less than two hundred dollars (\$200) and not more  
5 than two thousand dollars (\$2,000).

6                   (ii) An additional sentence of not more than twenty-  
7 four (24) hours of community service may be imposed under this subdivision  
8 (a)(1)(B).
