16	SECTION	N 3. EMERGENCY CLAUSE. It is found	d and determined by the General		
17	Assembly, that funds provided by the General Assembly for the operations of				
18	the Arkansas State Game and Fish Commission are, due to unforeseen				
19	circumstances, insufficient for the Arkansas State Game and Fish Commission				
20	to continue to provide essential governmental services; that the provisions				
21	of this act will provide the necessary monies for the Arkansas State Game and				
22	Fish Commission to continue such services; and that a delay in the effective				
23	date of this Act could work irreparable harm upon the proper administration				
24	and provision of essential governmental programs. Therefore, an emergency is				
25	hereby declared to exist and this Act being necessary for the immediate				
26	preservation of the public peace, health and safety shall be in full force				
27	and effect from and after the date of its passage and approval.				
28	If the l	oill is neither approved nor vetoe	d by the Governor, it shall become		
29	effective on the expiration of the period of time during which the Governor				
30	may veto t	the bill. If the bill is vetoed by	y the Governor and the veto is		
31	overridden	n, it shall become effective on the	e date the last house overrides
