## For An Act To Be Entitled

9 AN ACT TO REQUIRE THE OFFICE OF MOTOR VEHICLE OF  
10 THE REVENUE DIVISION OF THE DEPARTMENT OF FINANCE  
11 AND ADMINISTRATION TO GIVE NOTICE OF CHANGES IN  
12 THE DRIVING LAWS TO ALL PERSONS WHO REGISTER OR  
13 RENEW THEIR REGISTRATION FOR MOTOR VEHICLES AND  
14 TO ALL PERSONS WHO APPLY FOR OR RENEW THEIR  
15 DRIVER'S LICENSES; AND FOR OTHER PURPOSES.

18 TO REQUIRE THE OFFICE OF MOTOR VEHICLE  
19 TO GIVE NOTICE OF CHANGES IN THE DRIVING  
20 LAWS TO ALL PERSONS WHO REGISTER OR  
21 RENEW THEIR REGISTRATION FOR MOTOR  
22 VEHICLES AND APPLY FOR OR RENEW DRIVER'S

26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

28 SECTION 1. Arkansas Code Title 27, Chapter 14, Subchapter 6, is  
29 amended to add an additional section to read as follows:

30 27-14-609. Provision of information.

31 (a) The Office of Motor Vehicle of the Revenue Division of the  
32 Department of Finance and Administration shall maintain on its website  
33 information to inform the citizens of the State of Arkansas of changes in the  
34 driving laws of the state.

35 (b) The Office of Motor Vehicle of the Revenue Division of the  
36 Department of Finance and Administration shall include at the time of initial



1 registration or renewal of the registration of a motor vehicle under this  
2 chapter the following information related to changes in the driving laws of  
3 the State of Arkansas:

4 (1) The website address and information required under  
5 subsection (a) of this section; and

6 (2) A telephone number that a citizen of the State of Arkansas  
7 can call to obtain a written copy of changes in the driving laws of the  
8 state.

10 SECTION 2. Arkansas Code Title 27, Chapter 16, Subchapter 1 is amended  
11 to add an additional section to read as follows:

12 27-16-103. Provision of information.

13 (a) The Office of Motor Vehicle of the Revenue Division of the  
14 Department of Finance and Administration shall maintain on its website  
15 information to inform the citizens of the State of Arkansas of changes in the  
16 driving laws of the state.

17 (b) The Office of Motor Vehicle of the Revenue Division of the  
18 Department of Finance and Administration shall include at the time of  
19 application or renewal of a driver's license issued under this chapter the  
20 following information related to changes in the driving laws of the State of  
21 Arkansas:

22 (1) The website address and information required under  
23 subsection (a) of this section; and

24 (2) A telephone number that a citizen of the State of Arkansas  
25 can call to obtain a written copy of changes in the driving laws of the  
26 state.
