1	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the		
2	General Assembly of the State of Arkansas that the University of Central		
3	Arkansas is in dire need of additional student housing; that the provisions		
4	of this act will enable the University of Central Arkansas to acquire and		
5	lease student housing; and that it is necessary that this act become		
6	effective May 15, 2005 to enable the University of Central Arkansas to		
7	complete student housing plans before the beginning of the 2005 fall		
8	semester. Therefore, an emergency is declared to exist and this act being		
9	immediately necessary for the preservation of the public peace, health, and		
10	safety shall become effective on:		
11	(1) The date of its approval by the Governor;
