The Board of Trustees in its official governing capacity charged 2 with the management or control of the institution of higher learning and the President or Chancellor as the Chief Executive shall certify to the Chief 3 4 Fiscal Officer of the State and the Legislative Council that as of December 5 31 of each year that sufficient appropriations and funds are available, or 6 will become available, to meet all current and anticipated obligations during 7 the fiscal year for the payment of the obligations when they become due. 8 This certification, signed by the Chair of the Board of Trustees and the 9 President or Chancellor will be forwarded by February 28 of each year or upon release of the previous year's audit by Legislative Audit to the Chief Fiscal 10 11 Officer of the State and the Legislative Council accompanied by the Board 12 approved published annual financial statement for the preceding fiscal year. The provisions of this section shall be in effect only from July 1, 2003 13 14 2005 through June 30, <del>2005</del> 2007.

16 SECTION 12. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 17 by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the 18 19 restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 20 21 Procedures and Restrictions Act, the Higher Education Expenditures 22 Restrictions Act, or their successors, and other fiscal control laws of this 23 State, where applicable, and regulations promulgated by the Department of 24 Finance and Administration, as authorized by law, shall be strictly complied 25 with in disbursement of said funds.
