10	25-37-201. Creation - Appointment of secretary.
11	(a) There is created the Arkansas Agriculture Department.
12	(b)(1) The executive head of the department shall be the Secretary of
13	the Arkansas Agriculture Department.
14	(2) The Secretary shall be selected by the Arkansas Agriculture
15	Board and the name shall be submitted to the Governor for confirmation and
16	the Secretary shall serve at the pleasure of the Governor.
17	
18	25-37-202. Powers and duties.
19	The Arkansas Agriculture Department shall:
20	(1) Administer the departments, institutions, other agencies, or
21	parts of departments, institutions, or other agencies transferred to the
22	department under §§ 25-35-103 and 25-35-104;
23	(2) Coordinate all existing programs and create any new programs
24	that will enhance the marketing of the state's agricultural products to
25	intrastate, national, and international markets;
26	(3) Establish a clearinghouse for collecting, correlating,
27	analyzing, and interpreting marketing and educational information and data
28	concerning needs of and resources for agriculture, aquaculture, horticulture,
29	forestry, and kindred industries;
30	(4) Develop a website devoted to marketing and education
31	concerning agriculture, aquaculture, horticulture, forestry, and kindred
32	industries, including a distinctive logo publicizing products as "Grown in
33	Arkansas";
34	(5) Encourage the organization of neighborhood and county
35	agricultural clubs and associations;

20	25-37-203. Type 1 transfers of various agricultural agencies.
21	The following departments, institutions, other agencies, or parts
22	thereof are transferred to the Arkansas Agriculture Department by a type 1
23	transfer, as provided for in § 25-2-104, under which the departments,
24	institutions, other agencies, or parts thereof, shall be administered under
25	the direction and supervision of that principal department but shall retain
26	exactly the same prescribed statutory powers, authorities, duties, and
27	functions as they had before the transfer:
28	(1) Abandoned Pesticide Advisory Board, created under § 8-7-

2	25-37-204. Type 2 transfer of the Division of Agricultural Development
3	of the Arkansas Development Finance Authority.
4	The Division of Agriculture Development of the Arkansas Development
5	Finance Authority, created under § 15-5-802, is transferred to the Arkansas
6	Agriculture Department by a type 2 transfer, under which its statutory
7	authority, powers, duties, functions, records, personnel, property,
8	unexpended balances of appropriations, allocations, or other funds, including
9	the functions of budgeting or purchasing, are transferred to the department.

11	25-37-205. Transfer of human resources and accounting offices.
12	(a) The human resource and accounting operations of the following

17	(3) The Arkansas Forestry Commission; and

25	(a) The Arkansas Agriculture Board is created to consist of twenty

29	(A) Two (2) members, at least one (1) of whom shall be
30	actively engaged in farming, from the State Plant Board;

31	(b) The board shall advise the Secretary of the Arkansas Agriculture
32	Department on all matters concerning agriculture, aquaculture, horticulture,

34	(c) The board shall meet at least quarterly and shall fix a regular
35	date for the quarterly meeting.
36	(d)(1) The members of the board appointed by the Governor shall serve

1	staggered terms of four (4) years, to be determined at the first meeting of
2	the board by lot in a manner to result, as far as possible, in an equal
3	number of terms expiring each year.
4	(2) The members appointed by the Governor shall serve no more
5	than two (2) terms.
6	(e)(1) Vacancies due to death, resignation, refusal to serve, or other
