20	AN ACT TO CONNECT VARIOUS AGRICULTURE-
21	RELATED AGENCIES TO AN ARKANSAS
22	AGRICULTURE DEPARTMENT.

25	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
26	
27	SECTION 1. Findings.
28	The General Assembly finds that:
29	(1) Agriculture accounts for thirteen billion dollars
30	(\$13,000,000,000) or one-fifth $(1/5)$ of the gross state product of Arkansas;
31	(2) Two hundred ninety-one thousand (291,000) Arkansas jobs
32	directly involve or operate in support of agriculture;
33	(3) Agriculture and agriculture-related jobs account for twenty-
34	three percent (23%) of all employment in Arkansas;
35	(4) Responsibility for supporting agriculture in Arkansas is
36	spread across six (6) state agencies;

1	(5) Marketing of the agricultural products of Arkansas is made
2	extremely difficult by the diffusion of responsibility across six (6) state
3	agencies; and
4	(6) Marketing of the agricultural products of Arkansas would be
5	vastly improved if a central office were devoted to creating, publicizing,
6	and sustaining an information network for Arkansas farmers and ranchers.
7	
8	SECTION 2. Arkansas Code Title 25 is amended by adding the following
9	new chapter:
10	25-37-201. Creation - Appointment of secretary.
11	(a) There is created the Arkansas Agriculture Department.
12	(b)(1) The executive head of the department shall be the Secretary of
13	the Arkansas Agriculture Department.
14	(2) The Secretary shall be selected by the Arkansas Agriculture
15	Board and the name shall be submitted to the Governor for confirmation and
16	the Secretary shall serve at the pleasure of the Governor.
17	
18	25-37-202. Powers and duties.
19	The Arkansas Agriculture Department shall:
20	(1) Administer the departments, institutions, other agencies, or
21	parts of departments, institutions, or other agencies transferred to the
22	department under §§ 25-35-103 and 25-35-104;
23	(2) Coordinate all existing programs and create any new programs
24	that will enhance the marketing of the state's agricultural products to
25	intrastate, national, and international markets;
26	(3) Establish a clearinghouse for collecting, correlating,
27	analyzing, and interpreting marketing and educational information and data
28	concerning needs of and resources for agriculture, aquaculture, horticulture,
29	forestry, and kindred industries;
30	(4) Develop a website devoted to marketing and education
31	concerning agriculture, aquaculture, horticulture, forestry, and kindred
32	industries, including a distinctive logo publicizing products as "Grown in
33	Arkansas";
34	(5) Encourage the organization of neighborhood and county
35	agricultural clubs and associations;
36	(6) Coordinate the various activities of the department with

1	those of the federal government and other states on matters pertaining to
2	agriculture, aquaculture, horticulture, forestry, and kindred industries and
3	enter into agreements for that purpose;
4	(7) Coordinate with existing programs concerning agriculture,
5	aquaculture, horticulture, forestry, and kindred industries with the
6	University of Arkansas Division of Agriculture;
7	(8) Make any and all contracts and grants and employ, to the
8	extent funds are available, such personnel as may be necessary to carry out
9	the purposes of this chapter; and
10	(9) Assist other departments, agencies, and institutions of the
11	state and federal governments, when so requested, by performing services in
12	conformity with the purposes of this chapter.

14	25-37-203. Type 1 transfers of various agricultural agencies.
15	The following departments, institutions, other agencies, or parts
16	thereof are transferred to the Arkansas Agriculture Department by a type \underline{l}
L 7	transfer, as provided for in § 25-2-104, under which the departments,
18	institutions, other agencies, or parts thereof, shall be administered under
19	the direction and supervision of that principal department but shall retain
20	exactly the same prescribed statutory powers, authorities, duties, and
21	functions as they had before the transfer:
22	(1) Abandoned Pesticide Advisory Board, created under § 8-7-
23	<u>1204;</u>
24	(2) Arkansas Forestry Commission, created under § 15-31-101;
25	(3) Arkansas Livestock and Poultry Commission, created under §
26	<u>2-33-101; and</u>
27	(4) State Plant Board, created under § 2-16-206.

29	25-37-204. The Division of Agricultural Development of the Arkansas
30	Development Finance Authority Coordination of marketing programs.
31	The Division of Agriculture Development of the Arkansas Development
32	Finance Authority, created under § 15-5-802, shall coordinate all aspects of
33	its work concerning the marketing of the agricultural products of Arkansas
34	with the Secretary of the Arkansas Agriculture Department.
35	
36	25-37-205 Transfer of human resources and accounting offices

1	(a) The human resource and accounting operations of the following
2	boards and commissions shall be administered under the direction and
3	supervision of the Arkansas Agriculture Department:
4	(1) The State Plant Board;
5	(2) The Arkansas Livestock and Poultry Commission; and
6	(3) The Arkansas Forestry Commission.
7	(b) The boards and commissions subject to transfer of the
8	administration of human resource and accounting operations under subsection
9	(a) of this section shall make available to the department all records of
10	whatever type concerning their human resource and accounting operations.
11	
12	25-37-206. Arkansas Agriculture Board.
13	(a) The Arkansas Agriculture Board is created to consist of twenty
14	(20) voting members and eight (8) nonvoting ex officio members, as follows:
15	(1) Nine (9) members, appointed by their respective boards, who
16	sit on one (1) of the following boards or commissions:
17	(A) Two (2) members, at least one (1) of whom shall be
18	actively engaged in farming, from the State Plant Board;
19	(B) Two (2) members, at least one (1) of whom shall be
20	actively engaged in farming, from the Arkansas Livestock and Poultry
21	<pre>Commission;</pre>
22	(C) Two (2) members from the Arkansas Soil and Water
23	Conservation Commission;
24	(D) Two (2) members from the Arkansas Forestry Commission;
25	<u>and</u>
26	(E) One (1) member, at least one (1) of whom shall be
27	actively engaged in farming, from the Arkansas Rural Development Commission;
28	(2) Eleven (11) members, appointed by the Governor with the
29	consent of the Senate as follows:
30	(A) Three (3) members who are actively engaged in growing
31	rice, cotton, or small grains, including, but not limited to, corn sorghum,
32	soybeans, and wheat;
33	(B) Three (3) members who are actively involved in at
34	least one (1) of the following areas of the agricultural industry:
35	(i) Plant food, agricultural chemicals, or seed
36	merchandising:

I	<u>(ii) Meat processing;</u>
2	(iii) Grain processing;
3	(iv) Domestic food products, processing, and global
4	marketing;
5	(v) Aquaculture; and
6	(vi) The Arkansas Livestock Marketing Association;
7	<u>and</u>
8	(C) Five (5) members as follows:
9	(i) One (1) member who is actively engaged in
10	<pre>producing beef;</pre>
11	(ii) One (1) member who is actively engaged in
12	<pre>producing swine;</pre>
13	(iii) One (1) member who is actively engaged in
14	dairy farming;
15	(iv) One (1) member who is actively engaged in
16	producing poultry; and
17	(v) One (1) member who is actively engaged in
18	producing wine, grapes, fruits, or vegetables; and
19	(3) Eight (8) nonvoting ex officio members, as follows:
20	(A) The Vice President for Agriculture of University of
21	Arkansas System;
22	(B) The Dean of Agriculture of Arkansas State University;
23	(C) The Dean of Agriculture of the University of Arkansas
24	at Pine Bluff;
25	(D) A representative of the University of Arkansas for
26	Medical Sciences who is actively involved in nutrition teaching, research, or
27	both;
28	(E) A representative of the University of Arkansas at
29	Monticello;
30	(F) The President of the Arkansas Association of
31	Conservation Districts; and
32	(G) A representative of Southern Arkansas University; and
33	(H) A representative of Arkansas Tech University.
34	(b) The board shall advise the Secretary of the Arkansas Agriculture
35	Department on all matters concerning agriculture, aquaculture, horticulture,
36	and kindred industries.

1	(c) The board shall meet at least quarterly and shall fix a regular
2	date for the quarterly meeting.
3	(d)(1) The members of the board appointed by the Governor shall serve
4	staggered terms of four (4) years, to be determined at the first meeting of
5	the board by lot in a manner to result, as far as possible, in an equal
6	number of terms expiring each year.
7	(2) The members appointed by the Governor shall serve no more
8	than two (2) terms.
9	(e)(1) Vacancies due to death, resignation, refusal to serve, or other
10	causes among members of the board appointed by the Governor shall be filled
11	by appointment by the Governor of a qualified person to serve the remainder
12	of the unexpired term.
13	(2) A person so appointed is eligible for appointment to a
14	subsequent full term on the board.
15	(g)(1) State agency members of the board shall receive no additional
16	salary or compensation for their services as members of the committee, but
17	they may receive expense reimbursement in accordance with § 25-16-902, to the
18	extent funds are available.
19	(2) The members appointed by the Governor may receive expense
20	reimbursement from funds made available for that purpose in accordance with §
21	25-16-902, to the extent funds are available.

23	25-37-208. Agencies not affected.
24	The establishment of the Arkansas Agricultural Department shall in no
25	way affect the duties, powers, or operations of the following boards and
26	councils:
27	(1) Arkansas Beef Council;
28	(2) Arkansas Catfish Promotion Board;
29	(3) Arkansas Corn and Grain Sorghum Promotion Board;
30	(4) Arkansas Rice Research and Promotion Board;
31	(5) Arkansas Soybean Promotion Board; or
32	(6) Arkansas Wheat Promotion Board.
