22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES - GENERAL OPERATIONS. There is hereby
25 established for the Department of Higher Education for the 2005-2007
26 biennium, the following maximum number of regular employees whose salaries
27 shall be governed by the provisions of the Uniform Classification and
28 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and
29 all laws amendatory thereto. Provided, however, that any position to which a
30 specific maximum annual salary is set out herein in dollars, shall be exempt
31 from the provisions of said Uniform Classification and Compensation Act. All
32 persons occupying positions authorized herein are hereby governed by the
33 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
34 Code §21-5-101), or its successor.

SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LOANS. In order to provide timely payments under financial aid appropriations made in this Act, the Chief Fiscal Officer of the State is authorized to provide loans from the Budget Stabilization Trust Fund to make available all funds attributable to the financial aid programs under the then current official revenue estimates. In the event of an unanticipated state revenue shortfall, any such loans remaining at the end of a fiscal year shall be repaid from revenues distributed in the first two months of the next fiscal year. Funds for appropriations made in this Act for purposes other than financial aid shall not be affected by the application of this provision.

The provisions of this section shall be in effect only from July 1, 2003 ~~2005~~ through June 30, ~~2005~~ 2007.

SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. WORK FORCE 2000 DEVELOPMENT FUND PROCEDURES. After the amounts to be made available to the various technical colleges have been determined as set out in Arkansas Code 26-51-205(d)(2), such documents as may be necessary shall be processed so that funds may be transferred from the Work Force 2000

1 Development Fund to the State Treasury fund or fund account from which the
2 technical college draws its general revenue support. Such funds as may be
3 transferred shall not exceed ~~77.19%~~ 93.69% of the total funds available from
4 the Work Force 2000 Development Fund during each fiscal year of the biennial
5 period ending June 30, ~~2005~~ 2007.

6 In the event that a technical institute or comprehensive lifelong learning
7 center which receives support from the Work Force 2000 Development Fund as
8 determined by law transfers or merges into the Arkansas Technical College and
9 Community College System for which Work Force 2000 Development Fund monies
10 are determined by law, then the actual amount of support from the Work Force
11 2000 Development Fund in the preceding fiscal year for such educational
12 institution shall be made available irrespective of any other provision of
13 law which sets out maximum levels of support from such fund.

17 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

19 MAINTENANCE FUND. After the sum of \$13,200,000 has been deposited into the

28 EXPENDITURES. Proceeds derived from the repayment of loans as authorized *in*

30 Secondary Education Loans, the JR/SR Minority Teacher Scholars, ~~and~~ the
31 Minority Masters Fellows and the Targeted Teacher Development Program shall
32 be deposited into the State Treasury as "Refunds to Expenditures."

36 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

5 forward and made available for the same purpose for the fiscal year ending

10 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

12 GUARD TUITION ASSISTANCE PROGRAM. In addition to any other provisions of law,
13 any student who receives assistance from the appropriation made for the
14 "National Guard Tuition Assistance Program" in this Act shall repay any loans
15 and/or assistance if the student receives a discharge that is a less than
16 Honorable Discharge.

17 The provisions of this section shall be in effect only from July 1, ~~2003~~ 2005
18 through June 30, ~~2005~~ 2007.

20 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
22 GOVERNOR'S SCHOLARS PROGRAM. Should the funding of Governor's Scholars
23 Program exceed the funding level of the previous fiscal year and the number
24 of scholarships awarded increases to 200 or more, the Department of Higher
25 Education shall make every effort to assure a geographic distribution of the
26 awards without compromising the academic criteria established for such
27 awards.

28 The provisions of this section shall be in effect only from July 1, ~~2003~~

31 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COLLEGE
33 SAVINGS BONDS. The Department of Higher Education shall adopt rules and
34 regulations for the allocation of the funds reappropriated for the
35 development of projects at State Institutions of Higher Education and the
36 payment of project costs and expenses of the issuance of the bonds of the

1 Arkansas College Savings General Obligation Bonds Program to ensure that
2 funds are allocated and expended in a manner consistent with the provisions
3 of the Internal Revenue Code applicable to the Arkansas College Savings
4 General Obligation Bond Program (Program). The funds reappropriated for the
5 development of projects at State Institutions of Higher Education and the
6 payment of project costs and expenses of the issuance of the bonds of the
7 Arkansas College Savings General Obligation Bonds Program shall be allocated
8 and expended pursuant to the provisions of Arkansas Code 6-62-701 et. seq.
9 and other laws of this State. The expenditure and allocation of funds shall
10 be exempt from any other provisions of state law which conflicts with any
11 provision of the rules and regulations which rules and regulations are
12 required to ensure the compliance of the Program with the applicable
13 provisions of the Internal Revenue Code.

14 The provisions of this section shall be in effect only from July 1, ~~2003~~
15 2005 through June 30, ~~2005~~ 2007.

16

17 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COLLEGE
19 SAVINGS BONDS LIMITATIONS. The total principal amount of bonds to be issued
20 during any fiscal biennium shall not exceed three-hundred million dollars
21 (\$300,000,000), nor shall the principal amount of bonds outstanding at any
22 time have debt service requirements in excess of twenty-four million dollars
23 (\$24,000,000) in any one fiscal year from all sources.

24 The provisions of this section shall be in effect only from July 1, ~~2003~~

27 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

29 FORWARD - HEALTH EDUCATION GRANTS. The balance of the funds and

32 the same purposes for the fiscal year ending June 30, ~~2005~~ 2007.

36 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HEALTH
2 EDUCATION GRANTS - PRIORITIES. The Arkansas Higher Education Coordinating
3 Board, after consulting with the recognized associations of each of the
4 applicable medical professions and other interested persons, shall determine
5 the priorities for the applicable programs enumerated in the appropriation
6 made for "Health Education *Grants and Loans*" in this Act. The Arkansas
7 Department of Higher Education, if necessary, shall re-adjust the number of
8 positions for entering students to be funded for each applicable program
9 based upon the priorities determined by the board.

10 The provisions of this section shall be in effect only from July 1, ~~2003~~
11 2005 through June 30, ~~2005~~ 2007.

13 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
