SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 28 29 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND BALANCES - STATE BOARD OF NURSING FUND. (A) For all appropriations as 30 provided in this Act, the agency disbursing officer shall monitor the level 31 32 of fund balances in relation to expenditures on a monthly basis. If any 33 proposed expenditures would cause the State Board of Nursing Fund to decline 34 below six hundred sixty six thousand one hundred thirty two dollars 35 (\$666,132.00), the disbursing officer shall immediately notify the executive head of the agency. 3	SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
4	Assembly, that the Constitution of the State of Arkansas prohibits the
5	appropriation of funds for more than a two (2) year period; that the
6	effectiveness of this Act on July 1, 2005 is essential to the operation of
7	the agency for which the appropriations in this Act are provided, and that in
8	the event of an extension of the Regular Session, the delay in the effective
