23	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
24	General Assembly of the State of Arkansas that full-time law enforcement
25	instructors at the Arkansas Police Corps Training Program at the University
26	of Arkansas at Little Rock need access to restricted law enforcement training
27	classes and material to ensure that current skills are maintained while
28	instructing law enforcement personnel in basic police training and other law
29	enforcement training courses; and that a delay in the implementation of this
30	act will hamper the state's ability to provide training and certification of
31	an adequate number of law enforcement officers. Therefore, an emergency is
32	declared to exist and this act being immediately necessary for the
33	preservation of the public peace, health, and safety shall become effective
34	on:
35	(1) The date of its approval by the Governor;

(2) If the bill is neither approved nor vetoed by the Governor,

1	the expiration of the period of time during which the Governor may veto t	:he
2	bill; or	
3	(3) If the bill is vetoed by the Governor and the veto is	
4	overridden, the date the last house overrides the veto.
