25	SECTION 1. Ark	ansas Code § 16-81-106(g), pertaining t	o the authority
26	of certain law enforc	ement officers of the federal governmen	t to make arrests
27	of offenders against	the laws of the State of Arkansas, is a	mended to read as
28	follows:		
29	(g) The follow	ing persons employed as full-time law e	nforcement
30	officers by the feder	al, state, county, or municipal governm	ent, who are
31	empowered to effect a	n arrest with or without warrant for vi	olations of the
32	United States Code an	d who are authorized to carry firearms	in the
33	performance of their	duties, shall be empowered to act as of	ficers for the
34	arrest of offenders a	gainst the laws of this state and shall	enjoy the same
35	immunity, if any, to	the same extent and under the same circ	umstances as
36	certified state law e	nforcement officers:

23	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the General							
24	Assembly of the State of Arkansas that crime is a threat to the safety to the							
25	citizens of the State of Arkansas; that additional certified law enforcement							
26	officers can reduce the threat of crime; and that this act is immediately							
27	necessary because it will avoid delay in increasing the number of law							
28	enforcement officers that can arrest offenders of the laws of the State of							
29	Arkansas. Therefore, an emergency is declared to exist and this act being							
30	immediately necessary for the preservation of the public peace, health, and							
31	safety shall become effective on:							
32	(1) The date of its approval by the Governor;							
33	(2) If the bill is neither approved nor vetoed by the Governor,							
34	the expiration of the period of time during which the Governor may veto the							
35	bill; or							
36	(3) If the hill is vetoed by the Governor and the veto is							

1	overridden,	the	date	the	last	house	overrides	the	veto.
