22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for
25 the Office of the Prosecutor Coordinator for the 2005-2007 biennium, the
26 following maximum number of regular employees whose salaries shall be
27 governed by the provisions of the Uniform Classification and Compensation Act
28 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory
29 thereto. Provided, however, that any position to which a specific maximum
30 annual salary is set out herein in dollars, shall be exempt from the
31 provisions of said Uniform Classification and Compensation Act. All persons
32 occupying positions authorized herein are hereby governed by the provisions
33 of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-
34 101), or its successor.

SECTION 3. APPROPRIATION - LAW ENFORCEMENT AND PROSECUTORIAL PROGRAMS. There is hereby appropriated, to the Office of the Prosecutor Coordinator, to be payable from the Law Enforcement and Prosecutor Drug Enforcement Training

1 Fund, for Law Enforcement and Prosecutor Drug Enforcement Training of the
2 Office of the Prosecutor Coordinator for the biennial period ending June 30,
3 2007, the following:

10 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
12 TRANSFER. (a) Regular Salary and Personal Services Matching for one (1)
13 Attorney Specialist, Grade 25 position as authorized in Section 1 herein, to
14 be used for Drug Law Enforcement, shall be funded only from funds transferred
15 from the Special State Asset Forfeiture Fund to the State Central
16 Services Fund as direct revenues to the Office of Prosecutor Coordinator.

17 (b) On July 1, ~~2003~~ 2005, the Chief Fiscal Officer of the State and State
18 Treasurer shall transfer the sum of ~~fifty three thousand nine hundred thirty~~
19 ~~three dollars (\$53,933)~~ fifty five thousand five hundred fifty dollars
20 (\$55,550), from the Special State Asset Forfeiture Fund to the State Central
21 Services Fund there to be used for such purposes as stated in (a) herein.

22 (c) On July 1, ~~2004~~ 2006, the Chief Fiscal Officer of the State and State
23 Treasurer shall transfer the sum of ~~fifty five thousand three hundred eighty~~
24 ~~nine dollars (\$55,389)~~ fifty seven thousand fifty one dollars (\$57,051), from
25 the Special State Asset Forfeiture Fund to the State Central Services Fund
26 there to be used for such purposes as stated in (a) herein.

27 (d) The provisions of this section shall be in effect only from July 1, ~~2003~~
28 2005 through June 30, ~~2005~~ 2007.

30 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
31 by this act shall be limited to the appropriation for such agency and funds
32 made available by law for the support of such appropriations; and the
33 restrictions of the State Procurement Law, the General Accounting and
34 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
35 Procedures and Restrictions Act, or their successors, and other fiscal
36 control laws of this State, where applicable, and regulations promulgated by

1 the Department of Finance and Administration, as authorized by law, shall be
2 strictly complied with in disbursement of said funds.

3
4 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly
5 that any funds disbursed under the authority of the appropriations contained
6 in this act shall be in compliance with the stated reasons for which this act
7 was adopted, as evidenced by the Agency Requests, Executive Recommendations
8 and Legislative Recommendations contained in the budget manuals prepared by
9 the Department of Finance and Administration, letters, or summarized oral
10 testimony in the official minutes of the Arkansas Legislative Council or
11 Joint Budget Committee which relate to its passage and adoption.

12
13 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General
14 Assembly, that the Constitution of the State of Arkansas prohibits the
15 appropriation of funds for more than a two (2) year period; that the
16 effectiveness of this Act on July 1, 2005 is essential to the operation of
17 the agency for which the appropriations in this Act are provided, and that in
18 the event of an extension of the Regular Session, the delay in the effective
19 date of this Act beyond July 1, 2005 could work irreparable harm upon the
20 proper administration and provision of essential governmental programs.
21 Therefore, an emergency is hereby declared to exist and this Act being
22 necessary for the immediate preservation of the public peace, health and
23 safety shall be in full force and effect from and after July 1, 2005.
