24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26 SECTION 1. Arkansas Code § 5-14-110 is amended to read as follows:
27 5-14-110. Sexual indecency with a child.

28 (a) A person commits sexual indecency with a child if:

29 (1) Being eighteen (18) years ~~old~~ of age or older, the person
30 solicits another person who is less than ~~fifteen (15)~~ fourteen (14) years of
31 age or who is represented to be less than ~~fifteen (15)~~ fourteen (14) years of
32 age to engage in sexual intercourse, deviate sexual activity, or sexual
33 contact; ~~or~~

34 (2)(A) With the purpose to arouse or gratify the sexual desires
35 of himself or herself or those of any other person, the person purposefully
36 exposes his or her sex organs to another person who is less than ~~fifteen (15)~~



1 fourteen (14) years of age.

2 (B) It is an affirmative defense to prosecution under
3 subdivision (a)(2)(A) of this section if the person is within three (3) years
4 of age of the victim; or

5 (3) Being eighteen (18) years of age or older, the person causes
6 or coerces another person who is less than fourteen (14) years of age to
7 expose his or her sex organs or the breasts of a female with the purpose to
8 arouse or gratify the sexual desires of himself, herself, or another person.

9 (b) Sexual indecency with a child is a Class D felony.
