17	(2)(A) A school district's debt service funding supplement is

22	(B) The debt service funding supplement shall be
23	distributed quarterly.
24	(b) A school district qualifying for a debt service funding

3	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the
4	General Assembly of the State of Arkansas that the Arkansas Supreme Court has
5	determined that current public school academic facilities in Arkansas are
6	inadequate and inequitable; that the General Assembly established the Joint
7	Committee on Educational Facilities to inventory the current condition of
8	public school academic facilities and recommend methods for bringing public
9	school academic facilities into conformity with the court's constitutional
10	expectations; that the programs established in this act are derived from
11	recommendations of the joint committee and are part of a comprehensive
12	program for overseeing the provision of constitutionally appropriate public
13	school academic facilities across the state; that this program must be
14	implemented immediately for the good of public school students in Arkansas.
15	Therefore, an emergency is declared to exist and this act being immediately
16	necessary for the preservation of the public peace, health, and safety,
17	shall become effective on:
18	(1) The date of its approval by the Governor;
19	(2) If the bill is neither approved nor vetoed by the Governor,
20	the expiration of the period of time during which the Governor may veto the
21	bill; or
22	(3) If the bill is vetoed by the Governor and the veto is
23	overridden, the date the last house overrides the veto.
