22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code Title 27, Chapter 51, Subchapter 6 is amended
25 to add an additional section to read as follows:

26 27-51-604. Additional penalties.

27 (a) The penalties under this section shall be in addition to the
28 penalties provided under Title 27, Chapter 50, Subchapter 3 and the Arkansas
29 Criminal Code, § 5-1-101 et seq.

30 (b) A person who is found guilty of, pleads guilty to, or pleads nolo
31 contendere to a violation under this subchapter and the violation resulted in
32 the injury of another person shall be fined two hundred dollars (\$200) and
33 have his or her driver's license, permit, or nonresident operating privilege
34 suspended for a minimum of thirty (30) days.

35 (c) A person who is found guilty of, pleads guilty to, or pleads nolo
36 contendere to a violation under this subchapter and the violation resulted in



1 the serious bodily injury of another person shall be fined five hundred
2 dollars (\$500) and have his or her driver's license, permit, or nonresident
3 operating privilege suspended for a minimum of ninety (90) days.

4 (d) A person who is found guilty of, pleads guilty to, or pleads nolo
5 contendere to a violation under this subchapter and the violation results in
6 the death of another person shall be fined one thousand dollars (\$1,000) and
7 have his or her driver's license, permit, or nonresident operating privilege
8 suspended for a minimum period of one hundred eighty (180) days.
