35	degree in history from the University of Arkansas at Fayetteville; and was a
36	dedicated Razorback fan; and

3	Arkansas; and

5	WHEREAS, Mr. Nall's career in education and coaching included Hendrix
6	College in Conway, Arkansas; Morrilton High School in Morrilton, Arkansas;
7	and Sheridan High School in Sheridan, Arkansas; and

9	WHEREAS, Mr. Nall was a past president of the Arkansas Athletic
10	Association; served as Sheridan Postmaster; was an active member of the
11	Arkansas Democratic Party and the Senior Democrats of Arkansas; was a
12	Democratic National Committee supporter; and served as a Sergeant-of-Arms in
13	the Arkansas State Senate; and

15	WHEREAS, Mr. Nall worked diligently as a member of the Grant County
16	Museum Board of Directors in the founding and early development of the Grant
17	County Museum and was named Board Member Emeritus in February 2004; and

19	WHEREAS, Mr. Nall was preceded in death by his beloved wife, Muriel
20	Cole Slaughter Nall, in 2001; and
