30	including the Bronze Star, EAME Campaign Ribbon with three Battle Stars, the
31	Combat Infantry Badge, the Good Conduct Medal, the Army of Occupation Ribbon,
32	and the Germany Victory Ribbon; and

34	WHEREAS, upon return to Arkansas, Dick worked at South Central Electric
35	Cooperative, where he worked forty-four (44) years before retiring and served
36	as the assistant fire chief of the Arkadelphia Volunteer Fire Department and



1	was with the department for thirty (30) years; and

3	WHEREAS, Dick has served as a member of the Central Arkansas
4	Development Council Board, as a trustee of Davidson Campground and the Clark
5	County Fair Board, and as the scoutmaster for Boy Scout Troop 24; and

7	WHEREAS, Dick and his wife, the former Carolyn Arnold, are members of
8	the Third Street Baptist Church in Arkadelphia, proud parents of three (3)
9	sons, Mark, Ross, and Blake, the proud grandparents of four (4) grandsons and
10	one (1) granddaughter, and the proud great-grandparents of one (1) great-
11	grandson; and

14	Board of Directors for four (4) years and serving on the Clark County Quorum
