19 AN ACT CONCERNING FUNDING FOR CERTAIN  
20 LAWSUITS AGAINST THE STATE OF ARKANSAS

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26  
27 SECTION 1. Title 6, Chapter 1, Subchapter 1 of the Arkansas Code is  
28 amended to add an additional section to read as follows:

29 6-1-106. Use of public school funding for litigation.

30 Any moneys appropriated by the General Assembly for distribution to a  
31 public school district shall not be expended, used, or transferred by a  
32 school district if the expenditure, use, or transfer is for the purpose of  
33 engaging in or supporting in any manner litigation by a school district,  
34 individual, association, corporation, or other entity against the State of  
35 Arkansas, the State Board of Education, the Department of Education, any  
36 other state agency, or any state officer or employee if the litigation



1 concerns the adequacy or equity of the state's education system, including,  
2 but not limited to, the adequacy or equity of laws concerning school funding.
