17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 Each of the following state boards, by a majority vote of the total

3 performing any proper business of the board, and the board members shall
4 receive no other compensation, expense reimbursement, or in-lieu-of payments
5 except as provided in § 25-16-902:

4 examination, evaluation, or ~~inspections~~ inspection attended or for any day
5 while performing any proper business of the board, and the board members
6 shall receive no other compensation, expense reimbursement, or in-lieu-of
7 payments except as provided in § 25-16-902:
