SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 28 29 ASSOCIATION DUES. Of the amounts appropriated for regional contributions by 30 item (04) in Section 2 of this Act, three thousand dollars (\$3,000.00), or 31 three-sevenths (3/7) whichever is less of the appropriated or funded amount, 32 each fiscal year shall be allocated for membership dues for the lower 33 Mississippi Valley Flood Control Association and one thousand dollars 34 (\$1,000.00), or one-seventh (1/7) whichever is less of the appropriated or 35 funded amount, each fiscal year shall be allocated for membership dues for 36 each of the following associations: Ouachita River Valley Association, Red

1 River Valley Association, Arkansas Basin Association, and White River Valley 2 Coalition. 3 The provisions of this section shall be in effect only from July 1, 2005 2007 4 through June 30, 2007 2009. 5 6 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 7 by this act shall be limited to the appropriation for such agency and funds 8 made available by law for the support of such appropriations; and the 9 restrictions of the State Procurement Law, the General Accounting and 10 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 11 Procedures and Restrictions Act, or their successors, and other fiscal 12 control laws of this State, where applicable, and regulations promulgated by 13 the Department of Finance and Administration, as authorized by law, shall be 14 strictly complied with in disbursement of said funds. 15 16 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly 17 that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act 18 19 was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by 20 21 the Department of Finance and Administration, letters, or summarized oral 22 testimony in the official minutes of the Arkansas Legislative Council or 23 Joint Budget Committee which relate to its passage and adoption. 24 25 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General 26 Assembly, that the Constitution of the State of Arkansas prohibits the 27 appropriation of funds for more than a two (2) year period; that the 28 effectiveness of this Act on July 1, 2007 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in 29 30 the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 2007 could work irreparable harm upon the 31 32 proper administration and provision of essential governmental programs.
