19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21	SECTION 1. Arkansas Code § 24-7-713 is amended to read as follows:	
22	24-7-713. Monthly benefits - Redetermination.	
23	(a)(1) Beginning with the July 1 which is at least twelve (12) full	
24	months after the effective date of a monthly benefit, the amount of the	
25	benefit shall be redetermined effective each July 1, and the redetermined	
26	amount shall be payable for the ensuing year.	
27	(2) The redetermined amount shall be the base amount multiplie	
28	by the following percent: One hundred percent (100%) plus three percent (3%) $\frac{1}{2}$	
29	for each full year, but excluding any fraction of a year, in the period from	m
30	the effective date of the base amount to the current July 1.	
31	(3) In no event shall the redetermined amount be less than the	:
32	base amount.	
33	(4) As used in this section:	
34 25	(A) "The amount of the benefit otherwise payable" means

- 1 (B)(i) "Base amount" means the monthly amount of the 2 benefit upon which benefit redeterminations after retirement are based, as 3 provided in this section. 4 Base amount includes the amount of the benefit (ii) 5 otherwise payable plus any one-time increase or increases granted by 6 legislative change. 7 (iii) The effective date of the base amount shall be 8 the effective date of the benefit or, if any, the effective date of the last 9 increase in base amount, whichever is later. 10 (5) The redetermined amount under this subsection is not 11 considered a benefit enhancement under the limitations under § 24-1-106. 12 (b)(1)(A) Effective July 1, 1999, subject to the minimum financial conditions set forth in § 24-7-718, retirees, survivors, and beneficiaries 13 14 shall receive an increase in benefits of not less than fifty dollars (\$50.00) 15 per month. 16 (B) However, the Board of Trustees of the Arkansas Teacher 17 Retirement System may elect and is granted authority to increase the benefit 18 to retirees in an amount determined by the board, except that the benefit 19 increase shall not exceed two hundred dollars (\$200) seventy-five dollars 20 (\$75.00) per month. 21 (2)(A) Members retiring after July 1, 1999, but before July 1, 22 2007, and their survivors and beneficiaries, with five (5) or more years of 23 eredited actual service in the Arkansas Teacher Retirement System and their 24 survivors and beneficiaries, shall receive an additional benefit of not less 25 than fifty dollars (\$50.00) per month over and above their regular annuity. 26 (B) Members retiring on or after July 1, 2007, with ten 27 (10) or more years of actual service in the Arkansas Teacher Retirement 28 System, and their survivors and beneficiaries, shall receive an additional 29 benefit of not less than fifty dollars (\$50.00) per month over and above 30 their regular annuity. 31 (B)(C) However, the Board of Trustees may elect and is 32 granted authority to increase the additional benefit to members retiring in 33 an amount determined by the board, except that the additional benefit shall 34 not exceed two hundred dollars (\$200) seventy-five dollars (\$75.00) per

5	(4)(A) For the purpose of determining eligibility for the
6	increase in benefits provided under this subsection, "actual service" means
7	service rendered in a position covered by the Arkansas Teacher Retirement
8	System.
9	(B) "Actual service" does not include purchased or free
10	credited service or reciprocal service.
11	(c) Nothing contained in this section shall require the Arkansas
12	Public Employees' Retirement System to pay any portion of the benefits
13	provided for in this section.
14	
15	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
16	General Assembly of the State of Arkansas that the current laws applicable to
17	the Arkansas Teacher Retirement System regarding monthly stipends require
18	revision; that revisions are necessary to ensure the effective and efficient
19	operation of the system; and that the most effective time to make changes to
20	the retirement system is at the beginning of the state's fiscal year.
21	Therefore, an emergency is declared to exist and this act being immediately
22	necessary for the preservation of the public peace, health, and safety shall
23	become effective on July 1, 2007.
