22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES. There is hereby established for the  
25 Department of Arkansas Heritage for the 2007-2009 biennium, the following  
26 maximum number of regular employees whose salaries shall be governed by the  
27 provisions of the Uniform Classification and Compensation Act (Arkansas Code  
28 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.  
29 Provided, however, that any position to which a specific maximum annual  
30 salary is set out herein in dollars, shall be exempt from the provisions of  
31 said Uniform Classification and Compensation Act. All persons occupying  
32 positions authorized herein are hereby governed by the provisions of the  
33 Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101),  
34 or its successor.

27 containing all information set forth in item (2) above, along with a written  
28 statement as to the current status of the project, contract, purpose etc. for  
29 which the carry forward was originally requested no later than thirty (30)  
30 days prior to the time the Agency, Board, Commission or Institution presents  
31 its budget request to the Arkansas Legislative Council/Joint Budget  
32 Committee; and

33 (4) Thereupon, the Department of Finance and Administration shall  
34 include all information obtained in item (3) above in the biennial budget  
35 manuals and/or a statement of non-compliance by the Agency, Board, Commission  
36 or Institution.

1           The provisions of this section shall be in effect only from July 1,  
2 ~~2005~~ 2007 through June 30, ~~2007~~ 2009.

4           SECTION 38. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE  
5 ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
6 SPECIAL FUNDING PROVISION - REAL ESTATE TRANSFER TAX. For the biennium  
7 ending June 30, 2009, revenues derived from the tax levied by Arkansas Code §  
8 26-60-105(b) shall be credited by the Treasurer of State each fiscal year of  
9 the biennium in the order and percentage and amounts as follows:

10           (1) Three percent (3%) for distribution to the Constitutional Officers  
11 Fund and the State Central Services Fund;

12           (2) Of the eighty percent (80%) of the net amount to be credited to the  
13 Arkansas Natural and Cultural Resources Grants and Trust Fund, the first four  
14 million five hundred thousand dollars (\$4,500,000) shall be distributed to  
15 the General Revenue Fund Account of the State Apportionment Fund; and

16           (3) The remainder as provided in Arkansas Code § 15-12-103(b)(1) - (3).

17  
18           SECTION 39. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
19 by this act shall be limited to the appropriation for such agency and funds  
20 made available by law for the support of such appropriations; and the  
21 restrictions of the State Procurement Law, the General Accounting and  
22 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
23 Procedures and Restrictions Act, or their successors, and other fiscal  
24 control laws of this State, where applicable, and regulations promulgated by  
25 the Department of Finance and Administration, as authorized by law, shall be  
26 strictly complied with in disbursement of said funds.

27  
28           SECTION 40. LEGISLATIVE INTENT. It is the intent of the General Assembly  
29 that any funds disbursed under the authority of the appropriations contained  
30 in this act shall be in compliance with the stated reasons for which this act  
31 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
32 and Legislative Recommendations contained in the budget manuals prepared by  
33 the Department of Finance and Administration, letters, or summarized oral  
34 testimony in the official minutes of the Arkansas Legislative Council or  
35 Joint Budget Committee which relate to its passage and adoption.
