24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. REGULAR SALARIES - ABC ADMINISTRATION. There is hereby
27 established for the Department of Finance and Administration - Alcoholic
28 Beverage Control Division for the 2007-2009 biennium, the following maximum
29 number of regular employees whose salaries shall be governed by the
30 provisions of the Uniform Classification and Compensation Act (Arkansas Code
31 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
32 Provided, however, that any position to which a specific maximum annual
33 salary is set out herein in dollars, shall be exempt from the provisions of
34 said Uniform Classification and Compensation Act. All persons occupying
35 positions authorized herein are hereby governed by the provisions of the
36 Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101),

SECTION 2. EXTRA HELP. There is hereby authorized, for the Department of Finance and Administration - Alcoholic Beverage Control Division for the 2007-2009 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: one (1) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 3. APPROPRIATION - ABC ADMINISTRATION - CASH OPERATIONS. There is hereby appropriated, to the Department of Finance and Administration - Alcoholic Beverage Control Division, to be payable from the cash fund deposited in the State Treasury as determined by the Chief Fiscal Officer of the State, for operating expenses of the Department of Finance and Administration - Alcoholic Beverage Control Division for the biennial period ending June 30, 2009, the following:

5 SECTION 4. APPROPRIATION - ABC ADMINISTRATION - STATE OPERATIONS. There is

25 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized

26 by this act shall be limited to the appropriation for such agency and funds

27 made available by law for the support of such appropriations; and the

28 restrictions of the State Procurement Law, the General Accounting and

29 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

30 Procedures and Restrictions Act, or their successors, and other fiscal

31 control laws of this State, where applicable, and regulations promulgated by

32 the Department of Finance and Administration, as authorized by law, shall be

33 strictly complied with in disbursement of said funds.

34

35 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly

36 that any funds disbursed under the authority of the appropriations contained

1 in this act shall be in compliance with the stated reasons for which this act
2 was adopted, as evidenced by the Agency Requests, Executive Recommendations
3 and Legislative Recommendations contained in the budget manuals prepared by
4 the Department of Finance and Administration, letters, or summarized oral
5 testimony in the official minutes of the Arkansas Legislative Council or
6 Joint Budget Committee which relate to its passage and adoption.

7
8 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General
9 Assembly, that the Constitution of the State of Arkansas prohibits the
10 appropriation of funds for more than a two (2) year period; that the
11 effectiveness of this Act on July 1, 2007 is essential to the operation of
12 the agency for which the appropriations in this Act are provided, and that in
13 the event of an extension of the Regular Session, the delay in the effective
14 date of this Act beyond July 1, 2007 could work irreparable harm upon the
15 proper administration and provision of essential governmental programs.
16 Therefore, an emergency is hereby declared to exist and this Act being
17 necessary for the immediate preservation of the public peace, health and
18 safety shall be in full force and effect from and after July 1, 2007.
