1 (C)(i) For the year of service credit granted, pays to the 2 system the employee and employer contributions based on the greater of: 3 (a) The annual salary received by the member 4 for the member's first full year of credited service that precedes the fiscal 5 year in which the service is purchased; or 6 (b) The average of the three (3) highest 7 annual salaries earned at the time of purchase. 8 (ii) The member shall pay interest from the end of 9 that year of credited service to the date of payment in full. 10 Payment for service under this section shall be based on the 11 contribution rates in effect at the time of the purchase. 12 The payment shall be credited to the member's deposit account and is in addition to any regular member contributions. 13 14 (c) A member shall receive one (1) year of purchased service credit 15 for every five (5) years of compensated service in the Arkansas National 16 Guard or in the armed forces reserve. 17 The service in the Arkansas National Guard or in the armed forces reserve shall not become credited service under this system until: 18 19 (1) The member pays for all of the service in the Arkansas 20 National Guard or in the armed forces reserve, or a portion of the service in 21 one-year increments, at one (1) time in a single lump-sum payment; and 22 (2) The member has established five (5) or more years of actual 23 service in the system. 24 If a member ceases to be an active member before the service in 25 the Arkansas National Guard or in the armed forces reserve has been 26 established as system-credited service, the member payments contributed under 27 this section are refundable, together with regular interest. 28 (f)(1) This section is supplemental to § 24-2-502, and nothing in this section shall diminish the right of any member of the system to obtain 29 30 credited service in the system for active duty military service within the 31 limits permitted by § 24-2-502. 32 (2) However, no member is entitled to receive more than one (1) 33 year of credited service rendered by the member under this section. 34 (3)(2) No member is eligible to purchase service credit in more

than one (1) state-supported retirement system for service time in the

Arkansas National Guard or in the armed forces reserve.
