

21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code Title 24, Chapter 4, Subchapter 7 is amended		
24			
25	24-4-750. Quorum court members.		
26	(a) Any person who served as a quorum court member on January 1, 1975,		
27	may purchase up to ten (10) years of credited service in the Arkansas Public		
28	Employees' Retirement System if:		
29	(1) The service to be purchased would not make the quorum court		
30	member otherwise eligible for a retirement benefit in another retirement		
31	plan;		
32	(2) The service is purchased in a lump sum;		
33	(3) The person purchasing the credited service completes all		
34	forms and provides documentation as required by the system; and		
35	(4) The person has at least three (3) consecutive terms of		
36	service on the same quorum court.		



1	(b) Interest on the credited service purchased under this section		
2	shall be charged from the date it would have otherwise been reported to the		
3	system to the date paid.		
4	(c) Eligibility for the purchase of credited service under this		
5	section shall be dependent on attainment of five (5) years of actual service		
6	in the system.		
7	(d) The annuity amount for each year of quorum court service purchased		
8	under this section shall be four dollars (\$4.00) to a maximum of one hundred		
9	sixty dollars (\$160) monthly for all quorum court service.
