21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code § 5-14-110 is amended to read as follows:
24 5-14-110. Sexual indecency with a child.

25 (a) A person commits sexual indecency with a child if:

26 (1) Being eighteen (18) years of age or older, the person
27 solicits another person who is less than ~~fifteen (15)~~ eighteen (18) years of
28 age and is not the actor's spouse or who is represented to be less than
29 ~~fifteen (15)~~ eighteen (18) years of age and is not the actor's spouse to
30 engage in:

- 31 (A) Sexual intercourse;
32 (B) Deviate sexual activity; or
33 (C) Sexual contact;

34 (2)(A) With the purpose to arouse or gratify a sexual desire of
35 himself or herself or a sexual desire of any other person, the person
36 purposely exposes his or her sex organs to another person who is less than



1 ~~fifteen (15)~~ eighteen (18) years of age and is not the actor's spouse.

2 (B) It is an affirmative defense to a prosecution under
3 subdivision (a)(2)(A) of this section if the person is within three (3) years
4 of age of the victim; or

5 (3) Being eighteen (18) years of age or older, the person causes
6 or coerces another person who is less than ~~fourteen (14)~~ eighteen (18) years
7 of age and is not the actor's spouse to expose his or her sex organs or the
8 breast of a female with the purpose to arouse or gratify a sexual desire of
9 himself, herself, or another person.

10 (b) Sexual indecency with a child is a Class D felony.
