19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 5-14-110 is amended to read as follows:
22 5-14-110. Sexual indecency with a child.

23 (a) A person commits sexual indecency with a child if:

24 (1) Being eighteen (18) years of age or older, the person
25 *solicits another person who is less than fifteen (15) years of age or who is*
26 *represented to be less than fifteen (15) years of age to engage in:*

27 (A) Sexual intercourse;

28 (B) Deviate sexual activity; or

29 (C) Sexual contact;

30 (2)(A) With the purpose to arouse or gratify a sexual desire of
31 himself or herself or a sexual desire of any other person, the person
32 purposely exposes his or her sex organs to another person who is less than
33 *fifteen (15) years of age.*

34 (B) It is an affirmative defense to a prosecution under
35 subdivision (a)(2)(A) of this section if the person is within three (3) years
36 of age of the victim; or



1 (3) With the purpose to arouse or gratify a sexual desire of
2 himself or herself or a sexual desire of any other person, the person
3 purposely exposes his or her sex organs to another person who is less than
4 eighteen (18) years of age, and the actor is:

5 (A) Employed with the Department of Correction, Department
6 of Community Correction, any city or county jail, or any juvenile detention
7 facility, and the minor is in custody at a facility operated by the agency or
8 contractor employing the actor; or

9 (B) A professional under § 12-12-507(b) and is in a
10 position of trust or authority over the minor; or

11 (C) The minor's guardian, an employee in the minor's
12 school or school district, a temporary caretaker, or a person in a position
13 of trust and authority over the minor;

14 (4) With the purpose to arouse or gratify his or her sexual
15 desire or a sexual desire of another person, a person who is eighteen years
16 (18) of age or older:

17 (A) Causes or coerces another person who is less than
18 eighteen (18) years of age to expose his or her sex organs to another person;
19 and

20 (B)(i) Is employed with the Department of Correction,
21 Department of Community Correction, any city or county jail, or any juvenile
22 detention facility, and the minor is in custody at a facility operated by the
23 agency or contractor employing the actor;

24 (ii) Is a professional under § 12-12-507(b) and is
25 in a position of trust or authority over the minor; or

26 (iii) Is the minor's guardian, an employee in the
27 minor's school or school district, a temporary caretaker, or a person in a
28 position of trust or authority over the minor; or

29 (5) Being eighteen (18) years of age or older, the person causes
30 or coerces another person who is less than fourteen (14) years of age to
31 expose his or her sex organs or the breast of a female with the purpose to
32 arouse or gratify a sexual desire of himself, herself, or another person.

33 (b) Sexual indecency with a child is a Class D felony.
