1	As a pre-requisite to implementation of the rates of pay authorized in this
2	section, the Arkansas State Police shall submit a salary structure and
3	administration plan that addresses the recruiting and retention needs of the
4	Department for approval by the Chief Fiscal Officer of the State and approval
5	by the Arkansas Legislative Council or Joint Budget Committee.
6	
7	Determining the maximum number of employees and the maximum amount of
8	appropriation and general revenue funding for a state agency each fiscal year
9	is the prerogative of the General Assembly. This is usually accomplished by
10	delineating such maximums in the appropriation act(s) for a state agency and
11	the general revenue allocations authorized for each fund and fund account by
12	amendment to the Revenue Stabilization law. Further, the General Assembly
13	has determined that the Department of Arkansas State Police may operate more
14	efficiently if some flexibility is provided to the Department of Arkansas
15	State Police authorizing broad powers under this Section. Therefore, it is

All such overtime 15 payments shall be processed through the State Accounting System and shall be 16 in addition to the Regular Salaries and benefits accruing to the employee. 17 The provisions of this section shall be in effect only from July 1, 2005 2007 through June 30, 2007 2009. 18

20 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR 22 VEHICLE PURCHASE. The Department of Arkansas State Police is hereby 23 authorized to purchase motor vehicles from the appropriations authorized for 24 Capital Outlay in the State Police Operations appropriation in this Act. 25 Motor vehicles donated to Arkansas State Police and confiscated vehicles 26 used for Arkansas State Police operations shall not be included in the 27 maximum number of authorized passenger vehicles.

31 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. UNIFORM 33 EMPLOYEE HEALTH INSURANCE PROGRAM REPORTING. The Department of Arkansas 34 State Police shall report monthly to the Governor, the Chief Fiscal Officer 35 of the State and to the Arkansas Legislative Council or Joint Budget 36 Committee regarding the activity and condition for the uniformed employee

1 health insurance plan. The report shall include, but not limited to, the 2 beginning reserve fund balance, contributions made during the month, claims paid, and the ending fund balance of the month. Due to the necessity of maintaining public safety and the highly competitive job market conditions for law enforcement personnel, the Arkansas State Police is authorized special rates of pay for <u>all</u> current and new <u>Commissioned</u> employees up to the pay levels <u>IIM</u>. listed below:

21 Commissioned employees who are hired as State Police Troopers will be 22 considered Recruits within the grade 19 classification shall be eligible for 23 salary adjustments, to be determined by the Agency Director, not to exceed 24 Pay Level IIM.

Current commissioned uniform employees whose salaries were awarded a one time adjustment by Act 1609 of 2003 and whose salaries exceed Pay Level IV, shall not be considered as exceeding the line item maximum of the employee's assigned grade.

After completion of four and a half years of employment the Commissioned employee will be eligible for promotion to Trooper First Class, grade 20. After seven and a half years of employment, the employee will be eligible for promotion to Corporal, grade 21. Employees will be eligible for normal promotion increases as they advance to the classifications of Sergeant, Lieutenant, Captain, and Major. Any disciplinary actions taken against an employee may delay the promotional process.

13 SECTION 22. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 14 by this act shall be limited to the appropriation for such agency and funds 15 made available by law for the support of such appropriations; and the 16 restrictions of the State Procurement Law, the General Accounting and 17 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal 18 19 control laws of this State, where applicable, and regulations promulgated by 20 the Department of Finance and Administration, as authorized by law, shall be 21 strictly complied with in disbursement of said funds.

23 SECTION 23. LEGISLATIVE INTENT. 32 SECTION 24. EMERGENCY CLAUSE. It is found and determined by the General
