9 AN ACT TO MODIFY THE FEE FOR LICENSING AND
10 REGISTERING AN HISTORIC OR SPECIAL INTEREST
11 VEHICLE; AND FOR OTHER PURPOSES.

13 **Subtitle**

14 TO MODIFY THE FEE FOR LICENSING AND
15 REGISTERING AN HISTORIC OR SPECIAL
16 INTEREST VEHICLE.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. Arkansas Code § 27-15-2202(a)(1), regarding the
22 registration and fee for historic or special interest license plates, is
23 amended to read as follows:

24 (a)(1)(A) Any person who is the owner of an historic or special
25 interest vehicle that is ~~twenty-five (25)~~ thirty (30) or more years old at
26 the time of making application for registration or transfer of title may,
27 upon application, register it as an historic or special interest vehicle,
28 upon the payment of a fee of ~~seven dollars (\$7.00)~~ twenty-five dollars
29 (\$25.00) for each vehicle, and be furnished a license plate of distinctive
30 design to be displayed on each vehicle in lieu of the usual license plate.

31 (B) The fee levied under this section shall be deposited
32 into the State Treasury to the credit of the University of Arkansas Medical
33 Center Fund for exclusive use by the University of Arkansas for Medical
34 Sciences - Department of Audiology and Speech Pathology for the purchase of
35 hearing devices for patients over twenty-one (21) years of age.

1 SECTION 2. Arkansas Code § 27-15-2202(c), regarding the registration
2 and fee for historic or special interest license plates, is amended to read
3 as follows:

4 ~~Upon selling or otherwise relinquishing ownership of an historic~~
5 ~~or special interest vehicle, a collector may retain possession of the vehicle~~
6 ~~plate and transfer its registration to another vehicle of the same category~~
7 ~~in his or her possession, upon payment of one half (1/2) the fee prescribed~~
8 ~~in subsection (a) of this section.~~ The special license plate and
9 registration of an historic or special interest vehicle under this subchapter
10 shall not be transferred.

12 SECTION 3. Arkansas Code § 27-15-2202(d), regarding the registration
13 and fee for historic or special interest license plates, is amended to read
14 as follows:

15 (d)(1) A vehicle manufactured as a reproduction or facsimile of an
16 historic or special interest vehicle shall not be eligible for registration
17 under this section unless it has been in existence for ~~twenty-five (25)~~
18 thirty (30) years or more.

19 (2) The age shall be calculated from the date the vehicle was
20 originally assembled as a facsimile.
