26	SECTION 1. Creat	tion.	
27	(a) There is cre	eated the Arkansas Legislative Task	k Force for Review of
28	Sex Offenses Involving	Minors.	
29	(b) The task for	rce shall consist of the following	members:
30	(1) The Go	overnor or the Governor's designee;	<u>;</u>
31	(2) The Cl	hair of the House Interim Committee	e on Judiciary or the
32	chair's designee;		
33	(3) The Cl	hair of the Senate Interim Committe	ee on Judiciary or
34	the chair's designee;		
35	(4) The Cl	hair of the Senate Interim Committe	ee on Children and

31	minors to be appointed by the President Pro Tempore of the Senate;		
32	(19) Two (2) members with specialized knowledge, skills, or		
33	experience in the area of criminal law concerning sex offenses involving		
34	minors to be appointed by the Speaker of the House of Representatives; and		
35	(20) The Director of the Bureau of Legislative Research or the

1	(c)(1) The Chair of the House Interim Committee on Judiciary or the
2	chair's designee shall call the first meeting within thirty (30) days of the
3	effective date of this act and shall serve as chair at the first meeting.
4	(2) At the first meeting, the members of the task force shall
5	elect from its membership a chair and other officers as needed for the
6	transaction of its business.
7	(3)(A) The task force shall conduct its meetings at the State
8	<pre>Capitol.</pre>
9	(B) Meetings shall be held at least one (1) time every
10	three (3) months but may occur more often at the call of the chair.
11	(d) If any vacancy occurs on the task force, the vacancy shall be
12	filled by the same process as the original appointment.
13	(e) The task force shall establish rules and procedures for conducting
14	its business.
15	(f) Members of the task force shall serve without compensation but may
16	receive expense reimbursement according to Arkansas Code § 25-16-902 if an
17	appropriation is made for that purpose and funds are available.
18	(g) A majority of the members of the task force shall constitute a
19	quorum for transacting any business of the task force.
20	(h) The Bureau of Legislative Research shall provide staff for the
21	task force.
22	
23	SECTION 2. <u>Duties.</u>
24	(a) The Arkansas Legislative Task Force for Review of Sex Offenses
25	Involving Minors shall:
26	(1) Examine how the State of Arkansas responds to sex offenses
27	involving minors with a focus on criminal justice and public safety;
28	(2) Determine the best practices to prevent sex offenses
29	involving minors by conducting national research or by using other methods;
30	(3) Recommend more efficient methods of distributing and
31	spending limited public moneys to prevent sex offenses involving minors;
32	(4) Recommend to the General Assembly specific changes to the
33	law that will prevent sex offenses involving minors in the State of Arkansas
34	in the form of bill drafts;
35	(5) Recommend to the General Assembly specific changes to the
36	law that assist in the prosecution of perpetrators of sex offenses involving

1	minors in the State of Arkansas in the form of bill drafts; and		
2	(6) Provide the Legislative Council with a written explanation		
3	of the recommended legislative changes.		
4	(b) The task force shall make its final report along with any		
5	recommendations for proposed legislation to the Legislative Council no later		
6	than October 1, 2008.		
7	(c) The task force is abolished on June 30, 2009.
