8	SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
9	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
10	FORWARD. Such appropriation as is authorized in this Act which remains at the
11	end of the first fiscal year of the biennium may be carried forward into the

SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 19 20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER 21 PROVISIONS. The state-supported institution of higher education in this act 22 may transfer appropriations between the various line items within each 23 appropriation contained in this appropriation act. Such transfers shall be 24 made only after the approval of the Department of Higher Education and the 25 Chief Fiscal Officer of the State, and the approval of the Legislative 26 Council. 27 The General Assembly has determined that the institution in this act could 28 be operated more efficiently if some flexibility is given to that institution 29 and that flexibility is being accomplished by providing authority to transfer 30 between items of appropriation made by this act. 2	LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds
3	disbursed under the authority of the appropriations contained in this act
4	shall be in compliance with the stated reasons for which this act was
5	adopted, as evidenced by Initiated Act 1 of 2000, the Agency Requests,
6	Executive Recommendations and Legislative Recommendations contained in the
7	budget manuals prepared by the Department of Finance and Administration,
8	letters, or summarized oral testimony in the official minutes of the Arkansas
9	Legislative Council or Joint Budget Committee which relate to its passage and
10	adoption.
11	
12	SECTION 11. EMERGENCY CLAUSE. It is found and determined by the General
13	Assembly, that the Constitution of the State of Arkansas prohibits the
14	appropriation of funds for more than a two (2) year period; that the
15	effectiveness of this Act on July 1, 2007 is essential to the operation of
16	the agency for which the appropriations in this Act are provided, and that in
17	the event of an extension of the Regular Session, the delay in the effective
18	date of this Act beyond July 1, 2007 could work irreparable harm upon the
19	proper administration and provision of essential governmental programs.
20	Therefore, an emergency is hereby declared to exist and this Act being
21	necessary for the immediate preservation of the public peace, health and
22	safety shall be in full force and effect from and after July 1, 2007.
