6	(ii) If resale under subdivision (a)(3)(A)(i) of		
7	this section is authorized, any admission ticket to the event may be resold		
8	or offered for resale through any website if the website's operator		
9	guarantees a full refund of the amount paid for the admission ticket under		
10	each of the following conditions:		
11	(a) The event is cancelled;		
12	(b) The purchaser is denied admission to the		
13	event unless the denial of admission is due to the action or omission of the		
14	purchaser; and		
15	(c) The admission ticket is not delivered to		
16	the purchaser in the manner described on the website or pursuant to the		
17	delivery guarantee made by the reseller and failure of delivery results in		
18	the purchaser's inability to attend the event.		
19	(iii) A website operator's guarantee under		
20	subdivision (a)(3)(A)(ii) of this section shall be posted on the operator's		
21	website and a prospective purchaser shall be directed to the guarantee before		
22	completion of the resale transaction.		
23	(iv) A refund issued by a website operator pursuant		
24	to any condition under subdivision (a)(3)(A)(ii) of this section shall		
25	include any service, handling, or processing fees unless the service,		
26	handling, or processing fees are declared nonrefundable under the terms of		
27	the guarantee.		
28	(B) If authorization to resell an admission ticket for		
29	more than the price printed on the face of the admission ticket is not		
30	granted by the organizer of the event or the operator of the location of the		
31	event under subdivision (a)(3)(A)(i) of this section, a person or an entity		
32	shall not resell an admission ticket for more than the price printed on the		
33	face of the admission ticket.		
34	(C) A person or an entity shall not resell a student		
35	ticket issued by an Arkansas university for a sporting event for more than		
36	the price printed on the face of the student ticket.		

1	(b)(1) It is unlawful to knowingly purchase from the original ticket
2	seller a quantity of admission tickets to an event that exceeds the maximum
3	ticket limit quantity posted by or on behalf of the original ticket seller at
4	the point of original sale or printed on the admission tickets themselves
5	with the purpose to resell the admission tickets.
6	(2) A person or firm is not liable under subdivision (b)(1) of
7	this section with respect to admission tickets for which that person or firm
8	is the original ticket seller.
9	$\frac{(b)(1)}{(c)(1)}$ Any person, corporation, firm, or partnership violating
10	any provision of this section is guilty of a violation and upon conviction
11	shall be fined in any sum not less than twenty-five dollars (\$25.00) nor more
12	than five hundred dollars (\$500).
13	(2) Every sale or offer for sale is a separate offense.
14	(d) As used in this section, "original ticket seller" means the issuer
15	of admission tickets or a person or firm that provides distribution services
16	or admission ticket sales services under a contract with the issuer of
17	admission tickets.
