15 AN ACT TO REVISE THE REGIONAL MOBILITY AUTHORITY
16 ACT BY PLACING IT IN A STAND-ALONE CHAPTER IN THE
17 ARKANSAS CODE AND BY ADDING THE NECESSARY
18 PROVISIONS TO MAKE IT FEASIBLE FOR COUNTIES AND
19 CITIES TO UTILIZE; AND FOR OTHER PURPOSES.

21 **Subtitle**

22 TO REVISE THE REGIONAL MOBILITY
23 AUTHORITY ACT.
24
25

26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
27

28 SECTION 1. Arkansas Code Title 27 is amended to add an additional
29 chapter to read as follows:

30 CHAPTER 76

31 Subchapter 1 – General Provisions
32

33 27-76-101. Title.

34 This chapter is known and may be cited as the "Regional Mobility
35 Authority Act".
36



1 27-76-102. Legislative findings.

2 The General Assembly finds that:

3 (1) Many transportation projects cannot be completed because the
4 transportation construction and maintenance needs of the State of Arkansas
5 far exceed the budget for highway construction and maintenance;

6 (2) Counties and municipalities have limited budgets for
7 transportation construction and maintenance. As a result, they are often
8 unable to be financial partners with the Arkansas State Highway and
9 Transportation Department;

10 (3) Through the creation of regional mobility authorities
11 throughout the state, counties and municipalities are empowered to become
12 better partners for highway construction and maintenance with the Arkansas
13 State Highway and Transportation Department and the State Highway Commission;
14 and

15 (4) The funding of regional mobility authorities is intended to
16 supplement state and federal transportation funds. Such funding is not
17 intended to substitute for state and federal transportation aid to counties
18 and municipalities.

19
20 27-76-103. Definitions.

21 As used in this chapter:

22 (1)(A) "Bond" means a revenue bond or note issued under this
23 chapter by a regional mobility authority created under the Regional Mobility
24 Authority Act, § 27-76-101 et seq.

25 (B) "Bond" includes any other financial obligation of a
26 regional mobility authority authorized by this chapter, the laws of this
27 state, or the Arkansas Constitution;

28 (2)(A) "Compensation" means any payment for the value of the use
29 of time or the expenditure of moneys including without limitation:

30 (i) A salary; or

31 (ii) Per diem allowance.

32 (B) "Compensation" does not include reimbursement as
33 provided under § 27-76-302(d);

34 (3) "Debt service" means the amounts necessary for paying
35 principal, interest, trustee's and paying agent's fees, and rebate costs, and
36 the amounts necessary to establish and maintain debt service reserves as

1 provided in the authorizing resolution or trust indenture identified under
2 this chapter;

3 (4) "Governmental entity" means a lawfully created branch,
4 department, or agency of the federal, state, or local government;

5 (5) "Owner" means any individual, partnership, association,
6 corporation, or organization having any title or interest in any property,
7 rights, easements, and interest authorized to be acquired by and under the
8 regional mobility authority of this chapter;

9 (6) "Person" means any individual, partnership, corporation, or
10 other entity recognized by law as having power to contract;

11 (7) "Project development" means all phases of implementation
12 conducted in relation to a transportation project, including without
13 limitation:

14 (A) Planning;

15 (B) Environmental clearances;

16 (C) Surveys;

17 (D) Design;

18 (E) Utility adjustments;

19 (F) Right-of-way acquisition;

20 (G) Construction; and

21 (H) Construction inspection.

22 (8) "Public utility facility" means a facility that is either
23 publicly or privately owned and that provides direct or indirect utility
24 service to the public, including without limitation:

25 (A) Sewage and water pumping stations;

26 (B) Sewage and water treatment facilities;

27 (C) Telephone electronic structures; and

28 (D) Major electrical power lines, pipelines, or
29 substations whose major purpose is transport through a community;

30 (9) "Registered owner" means an owner of a motor vehicle as
31 shown on the vehicle registration records maintained by the Office of Motor
32 Vehicle or the analogous department or agency of another state or country;

33 (10)(A) "Toll facility project" means:

34 (i) Any new highway constructed under the provisions
35 of this chapter by a regional mobility authority as a toll road; and

36 (ii) All property, rights, easements, rights-of-way,

1 and interest that may be acquired by the regional mobility authority for or
2 in connection with the construction or operation of a toll road.

3 (B) "Toll facility project" includes without limitation
4 the following as the regional mobility authority deems necessary or desirable
5 for the operation of a toll road:

6 (i) Lands;

7 (ii) Rights-of-way;

8 (iii) Bridges;

9 (iv) Tunnels;

10 (v) Overpasses;

11 (vi) Underpasses;

12 (vii) Interchanges;

13 (viii) Entrance plazas;

14 (ix) Approaches;

15 (x) Toll houses;

16 (xi) Administration buildings;

17 (xii) Storage buildings;

18 (xiii) Other buildings; and

19 (xiv) Facilities;

20 (11)(A) "Toll facility project costs" means any direct and
21 indirect costs incurred in connection with the acquisition of rights-of-way
22 for and constructing and equipping toll facility projects, including without
23 limitation:

24 (i) The cost of the acquisition of all lands,
25 property, rights, rights-of-way, easements, and interests acquired by a
26 governmental entity;

27 (ii) The cost of demolishing or removing buildings
28 or structures on the land so acquired;

29 (iii) The cost of acquiring any lands to which those
30 buildings or structures may be moved;

31 (iv) The cost of all machinery and equipment;

32 (v) Financing charges, including interest accrued:

33 (a) Prior to construction;

34 (b) During construction; or

35 (c) For a period after construction;

36 (vi) The establishment of necessary funds and

1 reserves;

2 (vii) The cost of traffic estimates, engineering
3 fees, legal fees, plans, specifications, surveys, and estimates of cost and
4 revenues;

5 (viii) Administration expense, expenditures, or any
6 other expense that is necessary or incidental to determining the feasibility
7 or practicability of a toll facility project; and

8 (ix) Cost, expenditure, or any other expense that is
9 necessary or incidental to the construction of a toll facility project, the
10 finance of the construction, and the placement of the toll facility project
11 into operation.

12 (B) Any obligation, expense, or expenditure incurred or
13 made by the regional mobility authority for matters pertaining to a toll
14 facility project, including without limitation:

15 (i) Feasibility studies;

16 (ii) Traffic surveys;

17 (iii) Borings;

18 (iv) Preparation of plans and specifications;

19 (v) Engineering services; and

20 (vi) Cost, expenditure, or any other expense that is
21 regarded as part of the costs of a toll facility project and that may be
22 reimbursed to the State Highway Commission or other agency or department of
23 the state out of the proceeds of revenue bonds or out of any other available
24 funds of the commission;

25 (12) "Toll facility project revenues" means, without limitation,
26 any tolls, rentals, license and permit revenues, contractual receipts, gifts,
27 grants, moneys, charges, and other funds, including federal aid highway
28 funds, and property of whatever nature coming into the possession of or under
29 the control of the board of directors of the regional mobility authority by
30 virtue of this chapter, except the proceeds derived from the sale of revenue
31 bonds issued under this chapter;

32 (13) "Transponder" means a device placed on or within a vehicle
33 that is capable of transmitting or receiving information used to assess or
34 collect tolls;

35 (14) "Transportation project" means:

36 (A) Any part of a transportation system;

1 (B) Construction on or of any part of a transportation
2 system;

3 (C) Maintenance on or operation of any part of a
4 transportation system; or

5 (D) Preservation of any part of a transportation system;
6 and

7 (15) "Transportation system" means infrastructure that provides
8 mobility for people or goods in a region, including without limitation:

9 (A) Roads;

10 (B) Streets;

11 (C) Highways;

12 (D) Bridges;

13 (E) Tunnels;

14 (F) Sidewalks;

15 (G) Bicycle paths;

16 (H) Toll facilities;

17 (I) Pedestrian ways;

18 (J) Intermodal facilities;

19 (K) Port authorities;

20 (L) Railroads that are ninety-nine percent (99%) publicly
21 owned;

22 (M) Parking facilities;

23 (N) Public transit systems;

24 (O) Traveler information systems;

25 (P) Intelligent transportation systems;

26 (Q) Traffic management systems;

27 (R) Traffic signal systems;

28 (S) Safety improvements; or

29 (T) Any other means of surface or water transportation.

30
31 27-76-104. Exemption from taxation or assessment.

32 (a) A regional mobility authority is exempt from ad valorem property
33 taxation of or assessments on each of the following:

34 (1) A transportation system;

35 (2) A transportation project; and

36 (3) Property the regional mobility authority acquires or uses

1 under this chapter for a transportation project or transportation system.

2 (b) Income from the ownership or operation of the regional mobility
3 authority shall be exempt from state income tax.

4
5 27-76-105. Exemption from fees.

6 (a) Except as provided under subsection (b) of this section, a
7 regional mobility authority is exempt from the payment or assessment of any
8 of the following fees levied by a governmental entity, a property owner's
9 association, or a homeowner's association:

10 (1) Development fees;

11 (2) Utility connection fees;

12 (3) Assessments; and

13 (4) Service fees.

14 (b) This section does not apply to fees or assessments charged under
15 approved rate schedules or line extension policies of an electric or a gas
16 utility that is owned by a municipality.

17
18 27-76-106. Immunity.

19 (a) The powers and duties of a regional mobility authority conferred
20 by this chapter are public and governmental functions exercised for a public
21 purpose and for matters of public necessity.

22 (b) The exercise of the powers and the performance of the duties by a
23 regional mobility authority under this chapter are immune from suit in tort
24 unless immunity is expressly waived in writing.

25
26 27-76-107. Approval required.

27 Any design or proposal for a road or highway improvement must be
28 approved by the governmental entity that owns the roadway prior to the
29 commencement of the development of the transportation project.

30
31 Subchapter 2 – Creation

32
33 27-76-201. Authority to create.

34 (a) A single county may create a regional mobility authority by
35 adoption of an ordinance.

36 (b) A combination of contiguous counties may create a regional

1 mobility authority by each county:

2 (1) Adopting an ordinance that provides for the county's
3 participation in the regional mobility authority; and

4 (2) Entering into a joint agreement with the other participating
5 counties that states the jurisdictional boundaries of the regional mobility
6 authority.

7 (c) This section shall not limit additional contiguous counties or
8 municipalities from becoming a member in the regional mobility authority as
9 provided under § 27-76-203.

10
11 27-76-202. Purposes.

12 The purposes of a regional mobility authority created under this
13 chapter are to:

14 (1) Plan, construct, operate, or fund transportation projects of
15 the regional mobility authority; or

16 (2) Plan, construct, operate, or fund improvements to a
17 transportation system of the regional mobility authority.

18
19 27-76-203. Membership in a regional mobility authority.

20 (a) To become a member of a regional mobility authority, a governing
21 body of a municipality or county within the jurisdictional boundaries of the
22 regional mobility authority shall:

23 (1) Provide by ordinance for the participation of the
24 municipality or county in the regional mobility authority; and

25 (2) Enter into an agreement with the other participating members
26 if such members exist.

27 (b) The agreement between members of a regional mobility authority
28 shall establish the terms and conditions of the operation of the regional
29 mobility authority with the limitations provided in this chapter and other
30 applicable laws.

31 (c) To the extent that it is consistent with this chapter, the
32 agreement shall comply with the provisions of § 25-20-104(c).

33
34 27-76-204. Public corporation status.

35 Upon creation of a regional mobility authority:

36 (1) The regional mobility authority and its members shall:

- 1 (A) Constitute a public corporation; and
- 2 (B) Have perpetual succession; and
- 3 (2) The regional mobility authority and its members may:
- 4 (A) Contract and be contracted with;
- 5 (B) Sue and be sued in tort to the extent that it has
- 6 expressly waived liability in writing; and
- 7 (C) Have and use a common seal.

8

9 Subchapter 3 – Governance

10

11 27-76-301. Generally.

12 A regional mobility authority created under this chapter shall be

13 operated and controlled by a board of directors.

14

15 27-76-302. Board of directors.

16 (a) A board of directors shall manage and control each regional

17 mobility authority created under this chapter, including the following:

- 18 (1) Property;
- 19 (2) Operations;
- 20 (3) Business; and
- 21 (4) Affairs.

22 (b) The board of directors shall be solely responsible for selecting

23 the chair of the board of directors and establishing procedures by which it

24 shall operate.

25 (c) A director shall not receive compensation in any form from or for

26 his or her services as a director.

27 (d) Each director shall be entitled to reimbursement by the regional

28 mobility authority for any necessary expenditures incurred in connection with

29 the performance of his or her general duties as a director.

30

31 27-76-303. Membership on the board of directors.

32 (a) Unless the structure of the board of directors is otherwise

33 specified in the agreement establishing the regional mobility authority, the

34 board of directors of a regional mobility authority shall consist of no fewer

35 than five (5) directors as provided under this section.

36 (b)(1) The board of directors shall include the county judge or

1 designated representative of each county that is a member of the regional
2 mobility authority and the mayor or designated representative of each city of
3 the first class that is a member of the regional mobility authority.

4 (2) If the number of directors is fewer than five (5) after
5 fulfilling the requirements of subdivision (b)(1) of this section, then
6 mayors or designated representatives of the cities of the second class that
7 are members of the regional mobility authority are appointed to the board of
8 directors in descending order of population as determined by the last federal
9 decennial census until five (5) directors have been appointed.

10 (c) The designated representative of a county judge or mayor under
11 subsection (b) of this section shall be a qualified elector of the
12 jurisdiction that the designated representative is appointed to represent.

13 (d) If a city of the second class becomes a city of the first class
14 and is a member of the regional mobility authority, the mayor of that city or
15 designated representative shall become a director.

16 (e) Membership of cities of the second class on the board of directors
17 shall be adjusted after each federal decennial census.

18
19 27-76-304. Terms of directors.

20 (a) A director who is a public official may serve on the board of
21 directors during his or her term of office as the county judge or mayor of a
22 member of a regional mobility authority.

23 (b) A director who is the designated representative of the mayor or
24 county judge of a member of the regional mobility authority serves at the
25 pleasure of the mayor of the municipality or the county judge of the county
26 that is a member of the regional mobility authority.

27
28 Subchapter 4 – Powers and Duties

29
30 27-76-401. Powers generally.

31 The board of directors of a regional mobility authority created under
32 this chapter may:

33 (1) Make and adopt all necessary bylaws for its organization and
34 operation;

35 (2) Elect officers and employ personnel necessary for its
36 operation;

1 (3) Build, operate, maintain, expand, fund, or own a
2 transportation project or a transportation system;

3 (4) Apply for, receive, and spend grants for any purpose under
4 this chapter;

5 (5) Enter into contracts as provided in § 27-76-402;

6 (6) Enter into any agreement with any road or street improvement
7 district established under § 14-316-101 et seq., § 14-317-101 et seq., and §
8 14-322-101 et seq.;

9 (7) Enter into any agreement with the State Highway Commission
10 and the Arkansas State Highway and Transportation Department;

11 (8) Acquire lands and hold title to the lands acquired in its
12 own name;

13 (9) Acquire, own, use, and dispose of property in the exercise
14 of its powers and the performance of its duties under this chapter;

15 (10) Acquire any property necessary to carry out the purposes of
16 this chapter by exercising the power of eminent domain as provided under
17 subchapter 5 of this chapter;

18 (11) Enter into agreements or contracts as provided under this
19 chapter;

20 (12) Construct or change grade separations as provided under §
21 27-76-404;

22 (13) Fund feasibility studies as provided under §§ 27-76-405 and
23 27-76-406;

24 (14) Enter into agreements for joint transportation projects or
25 transportation systems between regional mobility authorities as provided
26 under § 27-76-407;

27 (15) Transfer a transportation project or transportation system
28 as provided under § 27-76-408;

29 (16) Develop and utilize financing options as provided under
30 subchapter 6 of this chapter;

31 (17) Issue revenue bonds and provide for the financing of
32 revenue bonds as provided under subchapter 6 of this chapter;

33 (18) Impose and collect tolls for a toll facility project owned
34 or operated by the regional mobility authority subject to voter approval as
35 provided under § 27-76-701(d);

36 (19) Impose and collect charges or rates for the use of a

1 transportation system or transportation project that is owned or operated by
2 the regional mobility authority, other than a toll facility project,
3 specifically to set:

4 (A) Passenger charges for public transit system users;

5 (B) Parking fees for users of parking decks or other
6 parking facilities;

7 (C) Ferry fees for the use of ferries;

8 (D) Passenger and freight fees for the use of railroads;

9 (E) Freight and user fees for the use of Intermodal and
10 port facilities;

11 (F) Access fees and charges for the use of traveler
12 information systems; or

13 (G) Other fees and charges that are usually and
14 customarily charged of users of a transportation system or a transportation
15 project;

16 (20) Index the cost for construction materials to the cost set
17 by the market;

18 (21) Request and receive from time to time from counties or
19 cities within the boundaries of the regional mobility authority funds to
20 finance and support the regional mobility authority, including county or city
21 turnback funds as set forth in §§ 27-70-206 and 27-70-207;

22 (22) Promote the use of a transportation project through
23 advertising or marketing as it determines to be appropriate, including the
24 promotion of a transportation project operated by a regional mobility
25 authority on behalf of another entity;

26 (23) Receive property or funds by gift or donation for the
27 finance and support of the regional mobility authority; and

28 (24) Do all things necessary or appropriate to carry out the
29 powers expressly granted or duties expressly imposed under this chapter.

30
31 27-76-402. Limitations.

32 (a) Notwithstanding any other provision of law, a regional mobility
33 authority shall not sell a toll facility project to a private entity or enter
34 into a lease for a toll facility or concession agreement related to a toll
35 facility.

36 (b) Notwithstanding any other provision of law, a toll facility

1 project established by a regional mobility authority shall be for
2 construction of new highways only.

3 (c) Notwithstanding any other provision of law, a regional mobility
4 authority shall not establish a toll facility project without voter approval
5 of the initial imposition of the tolls, including the initial toll rate and,
6 if revenue bonds are to be issued by the regional mobility authority to fund
7 all or a portion of the costs of the toll facility project, the issuance of
8 the maximum principal amount of bonded indebtedness.

9 (d) Notwithstanding any other provision of law, a regional mobility
10 authority shall not acquire or receive by conveyance a transportation project
11 or transportation system from another public or private entity that is either
12 completed or for which a construction notice to proceed has been issued to
13 convert the transportation project or transportation system to a toll
14 facility project.

15
16 27-76-403. Authority to contract.

17 (a) A regional mobility authority created under this chapter may enter
18 into agreements or contracts with a governmental entity or a private entity.

19 (b) The types of agreements or contracts that a regional mobility
20 authority may enter into under this chapter includes without limitation:

- 21 (1) Lease agreements;
- 22 (2) Rental agreements;
- 23 (3) Operating agreements;
- 24 (4) Service agreements;
- 25 (5) License agreements;
- 26 (6) Promotional agreements; and
- 27 (7) Purchasing agreements.

28 (c) The scope of agreements or contracts that a regional mobility
29 authority may enter into under this chapter includes without limitation:

30 (1) Rent, lease, or make property available for the benefit of
31 users of a transportation project or a transportation system other than a
32 public utility facility;

33 (2) Plan, design, construct, operate, or maintain a
34 transportation project on behalf of a governmental entity within the
35 boundaries of the regional mobility authority; and

36 (3) Acquire with the consent of a governmental entity or private

1 entity a transportation project or transportation system from that entity and
2 assume any debts, obligations, and liabilities of the entity relating to a
3 transportation project or transportation system transferred to the regional
4 mobility authority provided, that a regional mobility authority shall not
5 acquire a transportation project or transportation system from another public
6 or private entity that is completed or for which a construction notice to
7 proceed has been issued to convert the transportation project or
8 transportation system to a toll facility project.

9 (d) A regional mobility authority shall not sell a toll facility
10 project to a private entity or enter into a lease for a toll facility or a
11 concession agreement related to a toll facility.

12
13 27-76-404. Actions affecting existing roads – Grade separation.

14 (a) A regional mobility authority may construct a grade separation at
15 an intersection of a transportation project with a railroad or highway and
16 change the line of the railroad or grade of a highway to accommodate the
17 design of the grade separation as provided under this section.

18 (b) A regional mobility authority shall obtain consent from the
19 Arkansas State Highway and Transportation Department and the State Highway
20 Commission before constructing a grade separation under this section that
21 affects a segment of the state highway system.

22 (c) A regional mobility authority shall pay the cost of a grade
23 separation and any damage incurred in changing a line of a railroad or the
24 grade of a highway as part of the cost of the transportation project.

25 (d)(1) On request of the county, a regional mobility authority that
26 has changed the location of a segment of a county road as part of its
27 development of a transportation project shall reconstruct that segment of the
28 road at a location that the regional mobility authority determines restores
29 the utility of the road.

30 (2) On request of the city, a regional mobility authority that
31 has changed the location of a segment of a city road as part of its
32 development of a transportation project shall reconstruct that segment of the
33 road at a location that the regional mobility authority determines restores
34 the utility of the road.

35 (3) Determinations under this subsection (d) as to the
36 relocation of a road shall be at the discretion of the regional mobility

1 authority.

2 (4) Any reconstruction under this subsection (d) and the
3 associated costs of reconstruction are deemed to be in furtherance of a
4 transportation project.

5
6 27-76-405. Expenditures for feasibility studies.

7 (a) A regional mobility authority may pay the expenses of studying the
8 cost and feasibility and any other expenses relating to the preparation and
9 issuance of bonds for a proposed transportation project by:

10 (1) Using legally available revenue derived from an existing
11 transportation project;

12 (2) Borrowing money, issuing bonds, or entering into a loan
13 agreement payable out of legally available revenue anticipated to be derived
14 from the operation of an existing transportation project;

15 (3) Pledging to the payment of the bonds or a loan agreement
16 legally available revenue anticipated to be derived from the operation of a
17 transportation project; or

18 (4) Pledging to the payment of the bonds or loan agreement
19 legally available revenue to the regional mobility authority from another
20 source.

21 (b) Money spent by a regional mobility authority under this section
22 for a proposed transportation project shall be reimbursed to the
23 transportation project from which the money was spent from the proceeds of
24 bonds issued for the acquisition and construction of the proposed
25 transportation project.

26 (c) The use of any money of a transportation project to study the
27 feasibility of another transportation project or used to repay any money used
28 for that purpose does not constitute an operating expense of the
29 transportation project producing the revenue and may be paid only from the
30 surplus money of the transportation project as determined by the regional
31 mobility authority.

32
33 27-76-406. Reimbursement for feasibility studies.

34 (a) The following are allowable reimbursable expenses for studying the
35 cost and feasibility of a transportation project as provided under this
36 section:

1 (1) The preparation and issuance of bonds for the acquisition or
2 construction of a proposed transportation project by a regional mobility
3 authority; or

4 (2) The improvement, extension, or expansion of an existing
5 transportation project of the regional mobility authority.

6 (b) Any of the following may pay all or part of the expenses under
7 this section related to a transportation project and be reimbursed as
8 provided under this section:

9 (1) One (1) or more municipalities, counties, or other
10 governmental entities;

11 (2) A combination of municipalities, counties, or other
12 governmental entities;

13 (3) A governmental entity or private entity with its place of
14 business in this state; or

15 (4) An individual who resides in this state.

16 (c)(1) Funds expended under this section for a proposed transportation
17 project are reimbursable without interest and with the consent of the
18 regional mobility authority to the person paying the expenses as provided
19 under this section.

20 (2) The reimbursements shall be paid out of the proceeds from
21 revenue bonds issued for or other proceeds that may be used for the
22 acquisition, construction, improvement, extension, expansion, maintenance,
23 repair, or operation of the transportation project.

24
25 27-76-407. Joint transportation projects or joint transportation
26 systems between regional mobility authorities.

27 (a) If two (2) or more regional mobility authorities determine that
28 the traffic needs within the boundaries of each regional mobility authority
29 could be most efficiently and economically met by jointly operating two (2)
30 or more transportation projects in the separate regional mobility
31 authorities, then the regional mobility authorities may create one (1)
32 operational and financial enterprise to operate the transportation projects.

33 (b) If a regional mobility authority determines that a transportation
34 project could most efficiently and economically be acquired or constructed if
35 it were a part of the transportation system and that the addition will
36 benefit the system, the regional mobility authority may:

1 (1) Create more than one (1) transportation system and may
2 combine two (2) or more transportation systems into one (1) system; or

3 (2) Finance, acquire, construct, and operate additional
4 transportation projects as additions to or expansions of a transportation
5 system.

6 (c) The revenue of a transportation system that is merged under this
7 section shall be accounted for separately and shall not be commingled with
8 the revenue of a transportation project that is not a part of the
9 transportation system that was merged under this section or with the revenue
10 of another transportation system.

11
12 27-76-408. Transfer of a transportation project or transportation
13 system – Procedure.

14 (a) A regional mobility authority may sell, lease, or convey any of
15 its transportation projects or transportation systems to one (1) or more
16 governmental entities or a governmental entity may convey a transportation
17 project or a transportation system to a regional mobility authority if:

18 (1) The transferee has executed written commitments to assume
19 jurisdiction over the transferred transportation project or transportation
20 system;

21 (2) The property and contract rights in the transferred
22 transportation project or transportation system and bonds issued for the
23 project or system are not unfavorably affected by the transfer;

24 (3) The transfer is not prohibited under the bond proceedings
25 applicable to the transferred transportation project or transportation
26 system;

27 (4) An adequate provision has been made for the assumption of
28 all debts, obligations, and liabilities relating to the transferred
29 transportation project or transportation system by the regional mobility
30 authority or governmental entity that is assuming jurisdiction over the
31 transferred transportation project or transportation system;

32 (5) The transferee lawfully assumes:

33 (A) Jurisdiction over the transferred transportation
34 project or transportation system; and

35 (B) The debts, obligations, and liabilities of the
36 regional mobility authority relating to the transferred transportation

1 project or transportation system; and

2 (6) The transfer has been approved by the board of directors of
3 the regional mobility authority and the transferee or transferor.

4 (b) If the requirements of subsection (a) of this section are met,
5 then a regional mobility authority or governmental entity may transfer its
6 work product to determine the feasibility of the construction, improvement,
7 extension, or expansion of a transportation system or transportation project,
8 including without limitation:

9 (1) Traffic estimates;

10 (2) Revenue estimates;

11 (3) Plans;

12 (4) Specifications;

13 (5) Surveys;

14 (6) Appraisals;

15 (7) Financial work products; or

16 (8) Other work product developed by the regional mobility
17 authority or governmental entity to determine the feasibility of the
18 construction, improvement, extension, or expansion of a transportation
19 project or transportation system.

20 (c)(1) A regional mobility authority or governmental entity that
21 accepts a transfer under this section may reimburse the transferor for any
22 expenditures that it made prior to the transfer and any other amounts
23 expended under related agreements.

24 (2) The reimbursement may be made from the feasibility study
25 fund or other lawful funding source to pay the costs of work product for a
26 transferred transportation project or transportation system.

27 (3) The reimbursement may be made over time, as determined by
28 the parties.

29
30 27-76-409. Agreements to construct, maintain, and operate
31 transportation projects.

32 (a)(1) A regional mobility authority may enter into an agreement with
33 a governmental entity.

34 (2) For purposes of this section, a governmental entity may
35 include:

36 (A) The federal government;

- 1 (B) A state of the United States;
2 (C) Another governmental entity;
3 (D) A political subdivision of another governmental
4 entity; or
5 (E) A toll road corporation owned or operated by any
6 governmental entity.

7 (b)(1) A regional mobility authority may enter into an agreement to
8 allow a public or private entity to:

- 9 (A) Study the feasibility of a transportation project; or
10 (B) Design, construct, maintain, or repair a
11 transportation project.

12 (2) A regional mobility authority and one (1) or more entities
13 described under subsection (a) of this section may enter into a joint
14 agreement to study the feasibility of a transportation project or to acquire,
15 design, finance, construct, maintain, repair, operate, extend, or expand a
16 transportation project.

17 (3) A regional mobility authority shall not sell a toll facility
18 project to a private entity or enter into a lease for a toll facility or a
19 concession agreement related to a toll facility.

20 (c)(1) A regional mobility authority has broad discretion to negotiate
21 provisions in a development agreement through which a governmental entity or
22 private entity may contribute resources or improvements to a project.

23 (2) The development agreement may include provisions relating
24 to:

25 (A) The design, financing, and construction of a
26 transportation project in accordance with standards adopted by the regional
27 mobility authority; and

28 (B) Professional and consulting services to be rendered
29 under standards adopted by the regional mobility authority in connection with
30 a transportation project.

31 (d) A regional mobility authority shall not incur a financial
32 obligation on behalf of or guarantee the obligations of a governmental entity
33 or a private entity that constructs, maintains, or operates a transportation
34 project.

35 (e) A regional mobility authority or a county or municipality that is
36 a member of a regional mobility authority is not liable for any financial or

1 other obligation of a transportation project solely because a governmental
2 entity or a private entity constructs or finances part of a transportation
3 project.

4 (f) A regional mobility authority shall not directly provide water,
5 wastewater, natural gas, petroleum pipeline, electric transmission, electric
6 distribution, telecommunications, information, or cable television services.

7
8 27-76-410. Consistency of planning.

9 (a)(1) A regional mobility authority may develop plans for
10 transportation projects.

11 (2) The plans shall be consistent with state implementation
12 plans, statewide transportation improvement programs if federal aid funds are
13 involved, statewide long-range transportation plans, city and county master
14 street plans, and metropolitan transportation plans in metropolitan areas as
15 required under 23 U.S.C. § 134 as it existed on January 1, 2007.

16 (b) Nothing in this section shall interfere with the responsibility
17 and authority of metropolitan planning organizations to perform
18 transportation systems planning as required under 23 U.S.C. § 134 as it
19 existed on January 1, 2007.

20 (c) Nothing in this section shall interfere with the responsibility
21 and authority of the Arkansas State Highway and Transportation Department and
22 the State Highway Commission to perform transportation systems planning.

23
24 Subchapter 5 – Eminent Domain

25
26 27-76-501. Generally.

27 A regional mobility authority may acquire any property necessary to
28 carry out the public purposes of this chapter by exercising the power of
29 eminent domain.

30
31 27-76-502. Entering property.

32 (a) A regional mobility authority, its agents, or its employees may
33 with the consent of the owner enter upon real property to:

34 (1) Make surveys;

35 (2) Perform examinations;

36 (3) Take photographs;

1 (4) Perform tests or samplings; or

2 (5) Engage in other activities for the purpose of appraising the
3 property or determining whether it is suitable for the regional mobility
4 authority's purpose.

5 (b) If an owner of real property does not consent, a regional mobility
6 authority may seek a court order to enter a property under this section.

7
8 27-76-503. Condemnation petition.

9 (a) A regional mobility authority may exercise its power of eminent
10 domain by filing an appropriate petition in condemnation in the circuit court
11 of the county in which the property sought to be taken is situated to have
12 the compensation for right-of-way determined.

13 (b) The petition in condemnation shall describe the lands and property
14 sought to be taken.

15 (c) The regional mobility authority shall give the owner of the
16 property to be taken at least ten (10) days' notice in writing of the time
17 and place where the petition will be heard.

18 (d)(1) If the property sought to be taken is located in more than one
19 (1) county, the petition may be filed in any circuit court having
20 jurisdiction in any county in which any part of the property may be located.

21 (2) The proceedings held in the circuit court shall apply to all
22 of the property described in the petition.

23 (e) If the owner of the property sought to be taken is a nonresident
24 of the state, notice shall be made in accordance with the Arkansas Rules of
25 Civil Procedure.

26
27 27-76-504. Declaration of taking.

28 (a) When the immediate possession of lands and property is sought to
29 be obtained, the regional mobility authority may file a declaration of taking
30 with a court of competent jurisdiction at any time before judgment or
31 together with the petition in condemnation.

32 (b) The petitioner may file a declaration of taking at any time before
33 a judgment is signed or with the petition in condemnation in any proceeding
34 instituted by and in the name of the regional mobility authority that
35 involves the acquisition of real property, an interest in real property, or
36 an easement.

1 (c) The declaration of taking shall contain or have annexed to it the
2 following:

3 (1) A statement that the regional mobility authority is taking
4 the real property, the interest in the real property, or the easement;

5 (2) A statement of the purpose for which the regional mobility
6 authority is taking the real property, the interest in the real property, or
7 the easement for the use of the regional mobility authority;

8 (3) A description of the real property, the interest in the real
9 property, or the easement that the regional mobility authority is taking,
10 sufficient for the identification thereof;

11 (4) A plat showing the real property, the interest in the real
12 property, or the easement that the regional mobility authority is taking; and

13 (5) A statement of the amount of money estimated by the
14 acquiring regional mobility authority to be just compensation for the taking
15 of the real property, the interest in the real property, or the easement.

16
17 27-76-505. Condemnation proceedings and judgment.

18 (a) The circuit court shall impanel a jury of twelve (12) persons, as
19 in other civil cases, to ascertain the amount of compensation that the
20 regional mobility authority shall pay for the real property, the interest in
21 the real property, or the easement which the regional mobility authority is
22 taking.

23 (b) The matter shall proceed and be determined as in other civil
24 cases.

25 (c) In all cases of infants or incompetent persons, when no legal
26 representative or guardian appears in their behalf at the hearing, it shall
27 be the duty of the circuit court to appoint a guardian ad litem who shall
28 represent their interest for all purposes.

29 (d) Compensation shall be ascertained and awarded in the proceeding
30 and established by judgment therein.

31
32 Subchapter 6 – Financing and Bonds

33
34 27-76-601. Financing generally.

35 (a) A regional mobility authority may be financed or supported by
36 receiving the following:

1 (1) If requested and adopted, revenue from the levy by a member
2 county of a sales tax under § 26-74-201 et seq., § 26-74-301 et seq., and §
3 26-74-401 et seq. for the benefit of the regional mobility authority;

4 (2) If requested and adopted, revenue from the levy by a member
5 city of a sales tax under § 26-75-201 et seq. and § 26-75-301 et seq. for the
6 benefit of the regional mobility authority;

7 (3) Revenue from a motor vehicle tax imposed by a county that is
8 a member of a regional mobility authority under § 26-78-101 et seq.;

9 (4) If authorized by law, requested, and adopted, revenue from
10 the levy of an additional sales and use tax for the benefit of a regional
11 mobility authority by a county or city not to exceed one-half of one percent
12 (1/2 of 1%);

13 (5) Proceeds from tolls from toll facility projects owned by the
14 regional mobility authority;

15 (6) Proceeds from charges and rates imposed on surface
16 transportation systems owned by the regional mobility authority that are not
17 toll facility projects;

18 (7) Proceeds from the sale of bonds;

19 (8) State turnback funds received from counties that are members
20 of the regional mobility authority and cities that are within the boundaries
21 of a regional mobility authority, under §§ 27-70-206 and 27-70-207;

22 (9) Other state funding that is appropriated; or

23 (10) Other funds from a state agency.

24 (b) Taxes and tolls imposed under subdivisions (a)(1)-(5) of this
25 section shall be approved by voters pursuant to all applicable election laws.

26 (c)(1) A regional mobility authority shall not use revenue from a
27 transportation project in a manner that is not authorized by this chapter or
28 other law.

29 (2) Except as provided by this chapter, revenue derived from a
30 transportation project shall not be applied for a purpose or to pay a cost
31 other than a cost or purpose that is reasonably related to or anticipated to
32 be for the benefit of a transportation project.

33
34 27-76-602. Authority to issue bonds.

35 (a) If a regional mobility authority created under this chapter owns
36 or operates a transportation system and desires to construct improvements,

1 betterments, and extensions thereto, the regional mobility authority may
2 issue revenue bonds pursuant to a bond resolution and under the provisions of
3 this chapter to pay the cost of a transportation project or to pay all or
4 part of the cost of a transportation project that will become part of a
5 transportation system.

6 (b) If a regional mobility authority pursues the development of a toll
7 facility project, the regional mobility authority may issue revenue bonds
8 pursuant to a bond resolution and under the provisions of this chapter to pay
9 the toll facility project costs with toll facility project revenues.

10
11 27-76-603. Tax exempt status.

12 Bonds issued under this chapter and income from the bonds, including
13 any profit made on the sale or transfer of the bonds, are exempt from
14 taxation in this state.

15
16 27-76-604. Bond resolution required.

17 (a) Bonds issued in accordance with this chapter shall be authorized
18 by resolution of the board of directors of the regional mobility authority.

19 (b) The bonds may be issued as registered bonds and may be
20 exchangeable for bonds of another denomination or in another form.

21 (c) As determined in the bond resolution, the bonds of each issue
22 shall:

23 (1) Be dated;

24 (2) Bear interest at the rate or rates provided by the bond
25 resolution beginning on the dates provided by the bond resolution as
26 authorized by law, or bear no interest;

27 (3) Mature at the time or times provided by the bond resolution,
28 not exceeding forty (40) years from their date or dates; and

29 (4) Be made redeemable before maturity at the price or prices
30 and under the terms provided by the bond resolution.

31 (d) As determined in the bond resolution, the bonds of each issue may:

32 (1) Be in such form and denominations;

33 (2) Be payable at such places within or without the state; or

34 (3) Contain such terms and conditions as the members of the
35 regional mobility authority shall determine.

36 (e) The bonds shall have all of the qualities of and shall be deemed

1 to be negotiable instruments under the laws of the State of Arkansas, subject
2 to provisions as to registration as set forth in this section.

3 (f) The authorizing resolution may contain any other terms, covenants,
4 and conditions that the board of directors of the regional mobility authority
5 deem to be reasonable and desirable, including without limitation, those
6 pertaining to the:

7 (1) Maintenance of various funds and reserves;

8 (2) Nature and extent of any security for payment of the bonds;

9 (3) Custody and application of the proceeds of the bonds;

10 (4) Collection and disposition of revenues;

11 (5) Investment for authorized purposes; and

12 (6) Rights, duties, and obligations of the regional mobility
13 authority and the holders and registered owners of the bonds.

14 (g)(1) The authorizing resolution may provide for the execution of a
15 trust indenture between the regional mobility authority and any financial
16 institution within or without the State of Arkansas.

17 (2) The trust indenture may contain any terms, covenants, and
18 conditions that are deemed desirable by the board of directors of the
19 regional mobility authority, including without limitation those pertaining to
20 the:

21 (A) Maintenance of various funds and reserves;

22 (B) Nature and extent of any security for the payment of
23 the bonds;

24 (C) Custody and application of the proceeds of the bonds;

25 (D) Collection and disposition of revenues;

26 (E) Investment and reinvestment of any moneys during
27 periods not needed for authorized purposes; and

28 (F) Rights, duties, and obligations of the regional
29 mobility authority and the holders and registered owners of the bonds.

30 (h)(1) An authorizing resolution and trust indenture relating to the
31 issuance and security of the bonds shall constitute a contract between the
32 regional mobility authority and the holders or registered owners of the
33 bonds.

34 (2) The contract and all covenants, agreements, and obligations
35 in the contract shall be promptly performed in strict compliance with the
36 terms and provisions of the contract, and the covenants, agreements, and

1 obligations of the regional mobility authority may be enforced by mandamus or
2 other appropriate proceeding at law or in equity.

3 (i)(1) The resolution shall fix the minimum fees, fares, tolls, or
4 charges to be collected prior to the payment of all of the bonds, with
5 exceptions as may be provided in the resolution, and shall pledge the
6 revenues derived from the regional mobility authority's transportation system
7 or any specified portion of the regional mobility authority's transportation
8 system for the purpose of paying the bonds and interest on the bonds.

9 (2) The rates to be charged for the use of the regional mobility
10 authority's transportation system shall be sufficient to provide for the
11 payment of all principal of and interest on all bonds when due.

12 (j)(1) Additional bonds may be issued in the same manner to pay the
13 costs of a transportation project.

14 (2) Unless otherwise provided in the bond resolution, the
15 additional bonds shall be on a parity, without preference or priority, with
16 bonds previously issued and payable from the revenue of the transportation
17 project.

18 (3) A regional mobility authority may issue bonds for a
19 transportation project secured by a lien on the revenue of the transportation
20 project subordinate to the lien on the revenue securing other bonds issued
21 for the transportation project.

22
23 27-76-605. Sale.

24 (a) The bonds may be sold in such manner, either at public or private
25 sale, and upon such terms as the members of the regional mobility authority
26 shall determine to be reasonable and expedient for effectuating the purposes
27 of the regional mobility authority.

28 (b) The bonds may be sold at a price that the board of directors of
29 the regional mobility authority determine to be in the best interest of the
30 regional mobility authority, including sale at discount.

31 (c)(1) The bonds shall be executed by manual or facsimile signature of
32 the chair of the regional mobility authority and the manual or facsimile
33 signature of the secretary of the regional mobility authority or any other
34 officer of the regional mobility authority authorized to do so by resolution
35 of the board of directors.

36 (2) In case any of the officers whose signatures appear on the

1 bonds shall cease to be the officers before delivery of the bonds, their
2 signatures nevertheless shall be valid and sufficient for all purposes.

3 (d) Each bond shall be impressed or imprinted with the seal of the
4 regional mobility authority.

5
6 27-76-606. Proceeds.

7 (a) The proceeds of each bond issue shall be disbursed in the manner
8 and under any restrictions as provided in the bond resolution.

9 (b)(1) The proceeds derived from the sale of the bonds shall be used
10 solely for the purpose of:

11 (A) Making betterments, improvements, and extensions to
12 the surface transportation system owned and operated by the regional mobility
13 authority;

14 (B) Paying interest on the bonds during the period of
15 construction of the betterments, improvements, and extensions;

16 (C) Establishing any necessary reserves for the bonds;

17 (D) Paying the costs of issuing the bonds; and

18 (E) Paying any other costs and expenditures of whatever
19 nature incidental to the accomplishment of the betterments, improvements, and
20 extensions.

21 (2) The terms "betterments", "improvements", and "extensions"
22 include surface transportation systems as well as all other real and personal
23 property, buildings, structures, or other improvements or facilities as may
24 be necessary or advisable for the proper and efficient operation of the
25 regional mobility authority's surface transportation system.

26 (c) If the proceeds of a bond issue exceed the cost of the
27 transportation project for which the bonds were issued, the surplus shall be
28 segregated from the other money of the regional mobility authority and used
29 only for the purposes specified in the bond resolution.

30 (d) To the extent permitted under the applicable bond proceedings,
31 revenue from one (1) transportation project or toll facility project of a
32 regional mobility authority may be used to pay the cost of another
33 transportation project or toll facility project of the same regional mobility
34 authority.

35
36 27-76-607. Repayment.

1 (a) Bonds issued under the provisions of this chapter shall be payable
2 from revenues derived from the regional mobility authority's transportation
3 system.

4 (b) The bonds shall not in any event constitute an indebtedness of nor
5 pledge the faith and credit of the State of Arkansas or the county or
6 counties or municipality or municipalities creating the regional mobility
7 authority within the meaning of any constitutional provisions or limitations.

8 (c) It shall be plainly stated on the face of each bond that it:

9 (1) Is issued under the provisions of this chapter;

10 (2) Does not constitute an indebtedness of the State of Arkansas
11 or the county or counties or the municipality or municipalities creating the
12 regional mobility authority within any constitutional provisions or
13 limitations; and

14 (3) Is not backed by the full faith and credit of the State of
15 Arkansas or the county or counties or municipality or municipalities creating
16 the regional mobility authority.

17 (d) The bonds and the interest on the bonds shall be exempt from all
18 state, county, and municipal taxation, including without limitation, income
19 taxation and inheritance taxation.

20
21 27-76-608. Lien in favor of bondholders.

22 (a) The payment of the principal of bonds issued under this chapter
23 and the interest thereon may be secured by a lien on and security interest in
24 the regional mobility authority's surface transportation system or any
25 specified portion of the regional mobility authority's surface transportation
26 system.

27 (b) It shall not be necessary to the perfection of the lien and pledge
28 for such purposes that the trustee in connection with the bond issue or the
29 holders of the bonds take possession of the collateral security.

30 (c) Subject to whatever restrictions may be contained in the
31 resolution or indenture governing the bonds, any holder of bonds issued under
32 the provisions of this chapter may enforce either at law or in equity the
33 lien and may compel by proper suit the performance of the duties of the
34 officers of the board of directors of the issuing regional mobility authority
35 set forth in this chapter.

36 (d)(1) In the event there is default in the payment of the principal

1 or interest on any of the bonds, a court of competent jurisdiction may
2 appoint a receiver to:

3 (A) Administer the regional mobility authority's surface
4 transportation system pledged to the payment of the bonds; or

5 (B) Administer the specified portion of the regional
6 mobility authority's surface transportation system pledged to the payment of
7 the bonds.

8 (2) The receiver shall perform the duties specified in
9 subdivision (d)(1) of this section on behalf of the public body.

10 (3) The receiver shall have the power to:

11 (A) Charge and collect rates sufficient to provide for:

12 (i) The payment of the bonds;

13 (ii) The interest on the bonds;

14 (iii) The payment of any operating expenses of the
15 surface transportation system pledged to the payment of the bonds or the
16 portion of the surface transportation system pledged to the payment of the
17 bonds; and

18 (B) Apply the income and revenues of the surface
19 transportation system pledged to the payment of the bonds or the portion of
20 the surface transportation system pledged to the payment of the bonds in
21 conformity with this chapter and the resolution or indenture providing for
22 the issuance of the bonds.

23
24 27-76-609. Refunding bonds.

25 (a)(1) Bonds may be issued for the purpose of refunding any
26 obligations issued under this chapter or otherwise.

27 (2) The refunding bonds may be combined with bonds issued under
28 the provisions of § 27-70-314 into a single issue.

29 (b)(1) When bonds are issued under this section for refunding
30 purposes, the bonds may either be sold or delivered in exchange for the
31 outstanding obligations.

32 (2) If sold, the proceeds may, either at maturity or upon any
33 authorized redemption date, be either:

34 (A) Applied to the payment of the obligations refunded; or

35 (B) Deposited in escrow for the retirement thereof.

36 (c)(1) All bonds issued under this section shall in all respects be

1 authorized, issued, and secured in the manner provided for other bonds issued
2 under this chapter and shall have all the attributes of such bonds.

3 (2) The resolution or indenture under which the refunding bonds
4 are issued may provide that any of the refunding bonds shall have the same
5 priority of lien on the revenues pledged for their payment as was enjoyed by
6 the obligations refunded thereby.

7
8 27-76-610. Interim bonds.

9 (a) Before issuing definitive bonds, a regional mobility authority may
10 issue interim bonds with or without coupons exchangeable for definitive
11 bonds.

12 (b) The interim bonds may be authorized and issued in accordance with
13 this chapter without regard to a requirement, restriction, or procedural
14 provision in any other law.

15 (c)(1) A bond resolution authorizing interim bonds may provide that
16 the interim bonds recite that the bonds are issued under this chapter.

17 (2) The recital is conclusive evidence of the validity and the
18 regularity of the interim bonds' issuance.

19
20 27-76-611. Revolving fund.

21 (a) A regional mobility authority may maintain a revolving fund to be
22 held in trust by a banking institution chosen by the regional mobility
23 authority separate from any other funds and administered by the regional
24 mobility authority's board of directors.

25 (b) A regional mobility authority may transfer into its revolving fund
26 money from any permissible source, including:

27 (1) Funds from a transportation project if the transfer does not
28 diminish the money available for the project to less than any amount required
29 to be retained by the bond proceedings pertaining to the project;

30 (2) Funds received by the regional mobility authority from any
31 source and not otherwise committed, including money from the transfer of a
32 transportation project or system as provided under § 27-76-408 or the sale of
33 surplus assets of the regional mobility authority;

34 (3) Funds received from the Arkansas State Highway and
35 Transportation Department and the State Highway Commission; and

36 (4) Contributions, loans, grants, or assistance from any

1 governmental entity, private entity, or person.

2 (c) The regional mobility authority may use money in the revolving
3 fund to:

4 (1) Finance the acquisition, construction, maintenance, or
5 operation of a transportation project of a regional mobility authority
6 including the extension, expansion, or improvement of a transportation
7 project;

8 (2) Provide matching money required in connection with any

20 this chapter; and

21 (6) Provide for any other reasonable purpose that assists in the
22 financing of a regional mobility authority as authorized by this chapter.

23 (d)(1) Money spent or advanced from the revolving fund for a
24 transportation project or a transportation system must be reimbursed from the
25 money of that transportation project or transportation system.

26 (2) At the time that the expenditure or advancement is
27 authorized, a reasonable expectation of repayment must exist.

29 Subchapter 7 – Tolling

30
31 27-76-701. Setting tolling fees, fare, and other charges on a toll
32 facility project.

33 (a) A regional mobility authority shall set tolls, fees, fares, or
34 other charges at rates or amounts so that the aggregate of tolls, fees,
35 fares, or other charges from the transportation project, together with other
36 revenue of the project:

1 (1) Provides toll facility project revenue sufficient to pay:

2 (A) The toll facility project costs;

3 (B) The cost of maintaining, repairing, and operating the
4 transportation project; and

5 (C) The principal of and interest on any bonds issued for
6 the toll facility project as those bonds become due and payable; and

7 (2) Creates reserves for one (1) or more of the purposes stated
8 under subdivision (a)(1) of this section.

9 (b) A toll, fee, fare, or other charge imposed on an owner of a public
10 utility facility shall be imposed in a manner that is competitively neutral
11 and nondiscriminatory among similarly situated users of the toll facility
12 project.

13 (c) A toll, fee, fare, or other usage charge is not subject to
14 supervision or regulation by any agency of this state or other governmental
15 entity.

16 (d) Notwithstanding any of the provisions of this subchapter, a
17 regional mobility authority's power to charge tolls for use of a toll
18 facility project shall be subject to approval by the voters within the
19 boundaries of the regional mobility authority as follows:

20 (1) Voter approval of the initial imposition of the tolls
21 including the initial toll rate by the regional mobility authority; and

22 (2) If revenue bonds are to be issued by the regional mobility
23 authority to fund all or a portion of the costs of the toll facility project,
24 voter approval of the development of the toll facility project including the
25 initial toll rate and the issuance of the maximum principal amount of bonded
26 indebtedness.

27
28 27-76-702. Controlled access to toll facility projects.

29 (a) A regional mobility authority may adopt a resolution that
30 designates a toll road, a toll facility project, or a portion of a
31 transportation project as a controlled-access toll road.

32 (b) A regional mobility authority may adopt a resolution to:

33 (1) Prohibit the use of or access to or from a toll road by a
34 motor vehicle, bicycle, any other classification or type of vehicle, or a
35 pedestrian;

14 27-76-703. Tolling power subject to voter approval.

15 The approval of the voters within the boundaries of the regional
 16 mobility authority is required to authorize the development of a toll
 17 facility, the initial toll rate, and the maximum amount of bonded
 18 indebtedness pledged thereto subject to the provisions of 27-76-701(d).

20 27-76-704. Use of revenues – Revenue bonds.

21 (a)(1) Except as provided under subdivision (a)(3) of this section, a
 22 regional mobility authority that has issued revenue bonds for a toll facility
 23 project or a transportation project and that is financed with dedicated
 24 revenue derived from tolls, fees, fares, or other funds shall set aside
 25 moneys into a sinking fund that is pledged to and charged with the payment
 26 of:

27 (A) Interest on the bonds as it becomes due;

28 (B) Principal of the bonds as it becomes due;

29 (C) Necessary charges of paying agents for paying
