25	Assembly, that the Constitution of the Sta	ate of Arkansas pr	ohibits the	
26	appropriation of funds for more than a two	o (2) year period;	that the	
27	effectiveness of this Act on July 1, 2007	is essential to t	the operation of	
28	the agency for which the appropriations in	n this Act are pro	vided, and that in	
29	the event of an extension of the Regular S	Session, the delay	in the effective	
30	date of this Act beyond July 1, 2007 could	l work irreparable	harm upon the	
31	proper administration and provision of essential governmental programs.
