26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
27

28 SECTION 1. APPROPRIATIONS - ARKANSAS STATE UNIVERSITY - JONESBORO. There  
29 is hereby appropriated, to the Arkansas State University, to be payable from  
30 the General Improvement Fund or its successor fund or fund accounts, the  
31 following:

32 (A) For construction/replacement of Wilson Hall, the sum of...\$16,000,000.  
33

34 SECTION 2. APPROPRIATIONS - ARKANSAS TECH UNIVERSITY. There is hereby  
35 appropriated, to the Arkansas Tech University, to be payable from the General  
36 Improvement Fund or its successor fund or fund accounts, the following:



1 (A) For construction of an academic classroom facility, the sum of  
2 .....\$9,000,000.

3 (B) For construction/expansion of McEver Building Phase II, the sum of  
4 .....\$2,300,000.

5  
6 SECTION 3. APPROPRIATIONS - HENDERSON STATE UNIVERSITY. There is hereby  
7 appropriated, to the Henderson State University, to be payable from the  
8 General Improvement Fund or its successor fund or fund accounts, the  
9 following:

10 (A) For construction of a business building and renovation of Mooney Hall,  
11 the sum of .....\$7,000,000.

12  
13 SECTION 4. APPROPRIATIONS - SOUTHERN ARKANSAS UNIVERSITY - MAGNOLIA.  
14 There is hereby appropriated, to the Southern Arkansas University, to be  
15 payable from the General Improvement Fund or its successor fund or fund  
16 accounts, the following:

17 (A) For construction of a University Science Center, the sum of

19 (B) For renovation of the Wharton Nursing Building, the sum of...\$500,000.

21 SECTION 5. APPROPRIATIONS - UNIVERSITY OF ARKANSAS. There is hereby  
22 appropriated, to the University of Arkansas, to be payable from the General  
23 Improvement Fund or its successor fund or fund accounts, the following:

24 (A) For construction of a nanotechnology research center for the  
25 University of Arkansas - Fayetteville, the sum of .....\$22,000,000.

26 (B) For construction of a rice research and extension center for the  
27 University of Arkansas - Division of Agriculture, the sum of .....\$700,000.

28 (C) For construction of Cooperative Extension Headquarters Phase II for  
29 the University of Arkansas - Division of Agriculture, the sum of..\$7,000,000.

30 (D) For technology upgrades for the University of Arkansas - Division of  
31 Agriculture, the sum of .....\$500,000.

32 (E) For construction of a veterinary diagnostic laboratory for the  
33 University of Arkansas - Division of Agriculture, the sum of .....\$1,000,000.

34 (F) For construction of a Criminal Justice Institute building for the  
35 University of Arkansas - Criminal Justice Institute, the sum of ..\$2,750,000.

36 (G) For expansion/renovation of the University of Arkansas System Office

1 building for the University of Arkansas - System, the sum of .....\$200,000.

2 (H) For upgrades to science laboratories for the University of Arkansas -  
3 Arkansas School for Mathematics, Science and the Arts, the sum of ..\$500,000.

4 (I) For construction/land purchase of the Clinton School campus for the  
5 University of Arkansas - Clinton School, the sum of .....\$6,000,000.

8 hereby appropriated, to the University of Arkansas - Fort Smith, to be  
9 payable from the General Improvement Fund or its successor fund or fund  
10 accounts, the following:

11 (A) For construction of a modern language and fine arts building, the sum

14 SECTION 7. APPROPRIATIONS - UNIVERSITY OF ARKANSAS - LITTLE ROCK. There  
15 is hereby appropriated, to the University of Arkansas at Little Rock, to be  
16 payable from the General Improvement Fund or its successor fund or fund  
17 accounts, the following:

18 (A) For construction of a Cyber College, the sum of .....\$13,000,000.  
19 (B) For technology infrastructure upgrades, the sum of .....\$3,500,000.

20  
21 SECTION 8. APPROPRIATIONS - UNIVERSITY OF ARKANSAS - MONTICELLO. There is  
22 hereby appropriated, to the University of Arkansas at Monticello, to be  
23 payable from the General Improvement Fund or its successor fund or fund  
24 accounts, the following:

25 (A) For technology infrastructure, equipment and upgrades, the sum of  
26 .....\$1,000,000.

27 (B) For expansion/renovation of the Forest Resources Complex, the sum of  
28 .....\$5,750,000.

29  
30 SECTION 9. APPROPRIATIONS - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES.  
31 There is hereby appropriated, to the University of Arkansas for Medical  
32 Sciences, to be payable from the General Improvement Fund or its successor  
33 fund or fund accounts, the following:

34 (A) For construction of an education building, the sum of ....\$1,500,000.

35 (B) For renovation of the Arkansas State Hospital Space, the sum of  
36 .....\$5,000,000.

1 (C) For renovation of the Barton Research Building, the sum of  
2 .....\$5,400,000.

3 (D) For renovation of space for administrative offices for regional  
4 programs, the sum of .....\$2,000,000.

5  
6 SECTION 10. APPROPRIATIONS - UNIVERSITY OF ARKANSAS - PINE BLUFF. There  
7 is hereby appropriated, to the University of Arkansas at Pine Bluff, to be  
8 payable from the General Improvement Fund or its successor fund or fund  
9 accounts, the following:

10 (A) For campus renovations and repairs, the sum of .....\$7,030,000.

11 (B) For technology upgrades, the sum of .....\$270,000.

20 SECTION 29. APPROPRIATIONS - SOUTHEAST ARKANSAS COLLEGE. There is hereby  
21 appropriated, to the Southeast Arkansas College, to be payable from the  
22 General Improvement Fund or its successor fund or fund accounts, the  
23 following:

24 (A) For renovation of Technology Center North and Technology Center South,  
25 the sum of .....\$350,000.

26 (B) For construction of a library/classroom building, the sum of  
27 .....\$1,000,000.

28 (C) For renovation of Founders Hall, the sum of .....\$150,000.

29

30 SECTION 30. APPROPRIATIONS - SOUTHERN ARKANSAS UNIVERSITY - TECH. There  
31 is hereby appropriated, to the SAU-Tech, to be payable from the General  
32 Improvement Fund or its successor fund or fund accounts, the following:

33 (A) For construction of a technology/multi-purpose building, the sum of  
34 .....\$2,750,000.

35 (B) For expansion/renovation to the existing Environmental Academy  
36 classroom building, the sum of .....\$400,000.

4 SECTION 31. APPROPRIATIONS - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE -

6 Community College at Batesville, to be payable from the General Improvement  
7 Fund or its successor fund or fund accounts, the following:

8 (A) For construction of a nursing and allied health facility, the sum of  
9 .....\$1,500,000.

11 SECTION 32. APPROPRIATIONS - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE -  
12 HOPE. There is hereby appropriated, to the University of Arkansas Community  
13 College at Hope, to be payable from the General Improvement Fund or its  
14 successor fund or fund accounts, the following:

15 (A) For the construction of a science and technology center, the sum of  
16 .....\$300,000.

17 (B) For technology infrastructure upgrades, the sum of .....\$950,000.

18  
19 SECTION 33. APPROPRIATIONS - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE -  
20 MORRILTON. There is hereby appropriated, to the University of Arkansas  
21 Community College at Morrilton, to be payable from the General Improvement  
22 Fund or its successor fund or fund accounts, the following:

23 (A) For the construction of a health, physical education and recreation  
24 building, the sum of .....\$1,750,000.

25  
26 SECTION 34. APPROPRIATIONS - TWO-YEAR COLLEGE ECONOMIC DEVELOPMENT  
27 INCENTIVES. There is hereby appropriated, to the Department of Higher  
28 Education, to be payable from the General Improvement Fund or its successor  
29 fund or fund accounts, the following:

30 (A) For allocation by the Director of the Arkansas Department of Higher  
31 Education, to two-year colleges for economic development incentive grants,  
32 the sum of .....\$3,000,000.

33  
34 SECTION 35. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor  
35 obligations otherwise incurred in relation to the project or projects  
36 described herein in excess of the State Treasury funds actually available

1 therefor as provided by law. Provided, however, that institutions and  
 2 agencies listed herein shall have the authority to accept and use grants and  
 3 donations including Federal funds, and to use its unobligated cash income or  
 4 funds, or both available to it, for the purpose of supplementing the State  
 5 Treasury funds for financing the entire costs of the project or projects  
 6 enumerated herein. Provided further, that the appropriations and funds  
 7 otherwise provided by the General Assembly for Maintenance and General  
 8 Operations of the agency or institutions receiving appropriation herein shall  
 9 not be used for any of the purposes as appropriated in this act.

10 (B) The restrictions of any applicable provisions of the State Purchasing  
 11 Law, the General Accounting and Budgetary Procedures Law, the Revenue  
 12 Stabilization Law and any other applicable fiscal control laws of this State  
 13 and regulations promulgated by the Department of Finance and Administration,  
 14 as authorized by law, shall be strictly complied with in disbursement of any  
 15 funds provided by this act unless specifically provided otherwise by law.

16  
 17 SECTION 36. LEGISLATIVE INTENT. It is the intent of the General Assembly  
 18 that any funds disbursed under the authority of the appropriations contained  
 19 in this act shall be in compliance with the stated reasons for which this act  
 20 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
 21 and Legislative Recommendations contained in the budget manuals prepared by  
 22 the Department of Finance and Administration, letters, or summarized oral  
 23 testimony in the official minutes of the Arkansas Legislative Council or  
 24 Joint Budget Committee which relate to its passage and adoption.

25  
 26 SECTION 37. EMERGENCY CLAUSE. It is found and determined by the General  
 27 Assembly, that the Constitution of the State of Arkansas prohibits the  
 28 appropriation of funds for more than a two (2) year period; that the  
 29 effectiveness of this Act on July 1, 2007 is essential to the operation of  
 30 the agency for which the appropriations in this Act are provided, and that in  
 31 the event of an extension of the Regular Session, the delay in the effective  
 32 date of this Act beyond July 1, 2007 could work irreparable harm upon the  
 33 proper administration and provision of essential governmental programs.  
 34 Therefore, an emergency is hereby declared to exist and this Act being  
 35 necessary for the immediate preservation of the public peace, health and  
 36 safety shall be in full force and effect from and after July 1, 2007.
