SECTION 2. Arkansas Code § 25-19-106(b), concerning notice of public meetings, is amended to read as follows: (b)(1)(A) The time and place of each regular meeting shall be furnished to anyone who requests the information. (B)(i) Not less than ten (10) days prior to the date of a regularly scheduled meeting of its board of directors, a public school district shall publish on the public school district's website a notice of the date, time, and place of the meeting. (ii) Not less than twenty-four (24) hours prior to a rescheduled meeting, a public school district shall publish a notice on its website of the change in the date, time, or place of a regularly scheduled meeting. (2)(A) In the event of emergency or special meetings, the person calling the meeting shall notify the representatives of the newspapers, radio stations, and television stations, if any, located in the county in which the meeting is to be held and any news media located elsewhere that cover regular meetings of the governing body and that have requested to be so notified of emergency or special meetings of the time, place, and date of the meeting. (B) Notification shall be made at least two (2) hours before the meeting takes place in order that the public shall have representatives at the meeting.
