SECTION 2. Arkansas Code § 17-19-306 is amended to read as follows: 17-19-306. Posting of bondsmen list.

(a)(1) The chief law enforcement officers of any facilities having individuals or prisoners in their custody shall post in plain view in the facility housing those individuals or prisoners a list of <u>registered</u> bonding companies authorized to do business in the county provided by the circuit clerk.

16 (2) The list <u>shall be</u> prepared by the <u>circuit clerk and approved</u>
17 by the circuit court Professional Bail Bond Company and Professional Bail
18 Bondsman Licensing Board and shall contain the names of the professional bail
19 bond companies which that are registered with the circuit clerk with the
20 board for the purpose of being included on the list.

21 (3) This registration is for the purpose of being on the phone
