Arkansas Code § 14-238-108 is amended to read as follows: 14-238-108. Members - Compensation. 25 26 (a) Each board rural waterworks facilities board shall consist of five (5) members unless there is an expansion of the board to provide services 27 28 outside the county which created it. 29 (b)(1) The initial members shall be appointed by the county judge of the creating county for terms of one (1), two (2), three (3), four (4), and 30 31 five (5) years, respectively. (2) When a rural waterworks facilities board is created to 32 33 assume the operations of an existing nonprofit corporation that provides water or sewer service, the county judge shall appoint the initial members 34 from a list of nominees provided by the nonprofit corporation's board of 35 36 directors.

- 1 (3)(A) Successor members shall be elected by a majority of the
 2 <u>rural waterworks facilities</u> board or by alternative member selection as set
 3 forth in § 14-238-124 <u>or at the general election by the qualified electors of</u>
 4 the rural waterworks facilities board's service area for staggered terms of
 5 five (5) years each.
- 6 <u>(B) The quorum court and county judge of the creating</u>
 7 <u>county shall determine by ordinance how successor members shall be selected</u>
 8 to the rural waterworks facilities board.
- 9 (4) Each member shall serve until his <u>or her</u> successor is 10 elected and qualified.
- 11 (5) A member shall be eligible to succeed himself or herself.
 - (c) Each member shall qualify by taking and filing with the clerk of the county creating the <u>rural waterworks facilities</u> board his <u>or her</u> oath of office in which he <u>or she</u> shall swear to support the Constitution of the United States and the Constitution of the State of Arkansas and to discharge faithfully his or her duties in the manner provided by law.
- 17 (d) In the event of a vacancy in the membership of the <u>rural</u>
 18 <u>waterworks facilities</u> board, however caused, a majority of the <u>rural</u>
 19 <u>waterworks facilities</u> board shall elect a successor member to serve the
 20 unexpired term.
 - (e) The members of the <u>rural waterworks facilities</u> board shall receive no compensation for their services but shall be entitled to reimbursement for reasonable and necessary expenses incurred in the performance of their duties.
 - (f) Any member of the <u>rural waterworks facilities</u> board may be removed for misfeasance, malfeasance, or willful neglect of duty by the county judge of the county which created the <u>rural waterworks facilities</u> board, after reasonable notice of and an opportunity to be heard concerning the alleged grounds for removal.
- 30 (g)(1)(A) If the jurisdiction of a <u>rural waterworks facilities</u> board, 31 pursuant to interlocal agreements, expands to provide services outside the 32 boundaries of the county from which it obtains power, then not more than two 33 (2) additional members per county may be added pursuant to the terms of any 34 relevant interlocal agreement.
- 35 (B) These members shall initially be appointed by the 36 county judge of the noncreating county and shall serve for a term agreed upon

1	in the interlocal agreement, provided that the term shall not exceed five (5)
2	years.
3	(2)(A) The other provisions of this section shall apply to these
4	additional members.
5	(B) Provided, no additional member shall be eligible to
6	serve as chairman chair of the <u>rural waterworks facilities</u> board.
7	
8	SECTION 2. Arkansas Code § 14-238-124 is amended to read as follows:
9	14-238-124. Alternative membership selection.
10	(a) If so prescribed by ordinance of the creating county, successor
11	members of rural waterworks facilities boards shall be elected by a majority
12	of <u>board</u> members from a list of nominated candidates.
13	(b) A candidate may be nominated by petition of twenty-five (25) users
14	or ten percent (10%) of the number of total users as of January 1 preceding
15	the election, whichever is less. A petition shall be filed with the board
16	thirty (30) days prior to the expiration of the term of the member whose seat
17	the candidate seeks.
18	(c) Each water or sewer service connection, or both, shall be
19	considered a "user" for purposes of this chapter.
20	(d) Use of this alternative member selection may be prescribed by the
21	ordinance creating the board or the board may irrevocably select this method
22	of member selection by properly adopted resolution. The resolution shall be
23	filed with the county clerk of the creating county.
