3	SECTION 2. Arkansas Economic Development Commission renamed Arkansas		
4	Economic Development Council.		
5	(a)(1) The Arkansas Economic Development Commission, as it is referred		
6	to or empowered through the Arkansas Code, is renamed.		
7	(2) In its place, the Arkansas Economic Development Council is		
8	established, succeeding to the general powers and responsibilities previousl		
9	assigned to the Arkansas Economic Development Commission.

29	SECTION 7. The Arkansas Code Revision Commission shall make all		
30	changes in the Arkansas Code necessary to effectuate the intent of this act.

32	SECTION 8. EMERGENCY CLAUSE. It is found and determined by the		
33	General Assembly of the State of Arkansas that this act renames the		
34	Department of Economic Development and the Arkansas Economic Development		
35	Commission and that the ideal time to implement these names changes is at the		

beginning of the state's fiscal year. Therefore, an emergency is declared to

exist and this act being necessary for the preservation of the public phealth, and safety shall become effective on July 1, 2007.
