2	6-17-1207. Payment for unused leave.		
3	(a) Payment for unused sick leave shall be made from the salary fund		
4	of the district, and these moneys shall be included in meeting the annual		
5	requirements for payment of teachers' salaries.		
6	(b) Upon retirement, resignation, or other departure of employment, a		
7	school district may pay a teacher or administrator for accumulated unused		
8	sick leave. However, in no event shall the payment of accumulated unused		
9	sick leave exceed seven thousand five hundred dollars (\$7,500).		
10	(c) For administrators or other employees that may accumulate annual		
11	leave, upon retirement, resignation, or other departure of employment, a		
12	school district may pay the administrator or other employee for accumulated		
13	unused annual leave not to exceed thirty (30) days.
