23	SECTION 1. Arkansas Code § 6-14-102 is amended to read as follows:		
24	6-14-102. Annual school election date - Special school election.		
25	(a)(1) The annual school election shall be held in each school		
26	district of the state on the third <u>Tuesday next after the first Monday</u> in		
27	September November.		
28	(2) The annual school election shall only concern issues		
29	authorized to be on the ballot by the Arkansas Constitution or by statute,		
30	and no other issues shall appear on the ballot.

4 (c)(1) In any election year, if no more than one (1) candidate for 5 school district director presents a petition or notice in writing to the 6 county board of election commissioners as required by § 6-14-111 and if there 7 are no other ballot issues to be submitted to district electors for 8 consideration, the board of directors of any school district, by resolution 9 duly adopted, may request the county board of election commissioners to 10 reduce the number of polling places or to open no polling places on election 11 day so that the election can be conducted by absentee ballot and early voting 12 only.

13 (2) If requested by resolution adopted by the board of directors
14 of any school district, the county board of election commissioners may
15 provide that no polling places be open on election day so that the election
16 can be conducted by absentee ballot and early voting only, if:

17 (A) No more than one (1) candidate for school district
18 director presents a petition or notice in writing to the county board of

(3) In a county that uses voting machines or electronic vote

(d) The board of directors of any school district shall have the authority to request the county board of election commissioners to call a special election for the purpose of considering a rate of tax for additional millages for maintenance and operations or for debt service as authorized by Arkansas Constitution, Amendment 74, provided that:

31 (1) All constitutional and statutory requirements for a special 32 school election are met;

33 (2) The date of the election is approved by the commissioner;34 and

35 (3)(A) The special election is held on the second Tuesday of any
36 month, except as provided in subdivision (d)(3)(B) of this section.

(B)(i)(a) Special elections held in months in which a presidential preferential primary election, preferential primary election, general primary election, or general election is scheduled to occur shall be held on the date of the presidential preferential primary election, preferential primary election, general primary election, or general election. (b)(l)(A) If a special election is held on the date of the presidential preferential primary election, preferential primary election, or general primary election, the issue or issues to be voted upon at the special election shall be included on the ballot of each political party. (B) However, separate ballots containing only the issue or issues to be voted upon at the special election shall be prepared and made available to voters requesting a separate ballot. (2) No voter shall be required to vote in a political party's presidential preferential primary, preferential primary, or general primary in order to be able to vote at the special election. (ii) Special elections scheduled to occur in a month in which the second Tuesday is a legal holiday shall be held on the third Tuesday of the month.
