Privacy shall be provided by each county board of election 18 19 commissioners or county clerk to ensure that voters desiring privacy are not 20 singled out. 21 (b)(1) A voter shall inform the election officials or county clerk at 22 the time that the voter presents himself or herself to vote that he or she is 23 unable to mark the ballot because he or she cannot read or write or because 24 of physical, sensory, or other disability or other legal cause. 25 (2) The voter shall be directed to a voting machine equipped for 26 use by persons with disabilities where he or she may elect to cast his or her 27 ballot without assistance, or the voter may request assistance with either 28 the paper ballot or the voting machine, depending on the voting system in use 29 for the election, by: 30 (A) Two (2) election officials; or 31 (B) A person named by the voter. 32 If the voter is assisted by two (2) election officials, one 33 (1) of the election officials shall observe the voting process and one (1) 34 may assist the voter in marking and casting the ballot according to the 35 wishes of the voter without comment or interpretation.

  - (c) Any voter who because of physical, sensory, or other disability who presents himself or herself for voting and who then informs an election official at the polling site that he or she is unable to stand in line for extended periods of time shall be entitled to and assisted by an election official to advance to the head of any line of voters then waiting in line to vote at the polling site.

- 34 (a) At least one (1) election official in each precinct or at each box
  35 shall mark the voter's name as having voted on the precinct voter
  36 registration list furnished by the county clerk.

- 1 (b) If a voter's name does not appear on the precinct voter
  2 registration list, the voter may vote only in accordance with § 7-5-306.

- SECTION 11. Arkansas Code § 7-5-315 is amended to read as follows: 11 7-5-315. Counting ballots at the polling site.
- In counting the ballots at the polling site, the following procedures shall be followed:
  - (1) The votes received by an unopposed candidate in any election held in this state shall not be counted or tabulated by the election officials. The word "UNOPPOSED" shall be sufficient to insert on the tally sheet to indicate that the candidate has received a majority of the votes cast in the election. However, the votes received by an unopposed candidate for the office of mayor or circuit clerk shall be counted and tabulated by the election officials;
  - (2) No write-in vote in any election in this state may be counted unless the name of the write-in candidate shall have been written on the ballot in the handwriting of the person casting the vote;
  - (3) In counting the ballots, the ballot box shall be opened, and the ballots shall be counted by counting each ballot in turn or by counting by offices and issues. The election officials must witness the counting of the ballots and shall keep separate tally lists of the votes cast for each candidate or issue on the ballot;
  - (4) When two (2) or more ballots are found folded together, it shall be considered as conclusive evidence of their being fraudulent, and neither of them shall be counted. If a ballot shall be found to contain a greater number of names for any one (1) office than the number of persons required to fill the office, it shall be considered fraudulent as to the whole of the names designated to fill the office, but no further;
  - (5) Upon the close of the polls, the election officials shall immediately certify and attest the list of voters and continue the count to

1 completion. If any of the election officials become sick or incapacitated 2 from any other cause, the remaining election officials shall continue the 3 count until it is completed; 4 (6) After the count is completed, the election officials shall 5 make out the certificates of election in triplicate and immediately post one 6 (1) copy outside the polling site; and 7 (7)(A) The votes received by any person whose name appeared on 8 the ballot and who withdrew or died after the certification of the ballot or 9 filing period ended shall be counted. 10 (B)(i) If the person received enough votes to win 11 nomination or election, a vacancy in the nomination or election shall be 12 declared. (ii)(a) If the person received enough votes to 13 14 qualify for a runoff, the person's name shall appear on the runoff ballot; 15 and 16 (b) If enough votes are cast for the person to 17 win the runoff, then a vacancy in the nomination or election shall exist; and 18 (8) Any person who votes in an election as a result of a federal 19 or state court order or any other order extending the time established for 20 closing the polls may only vote in that election by casting a provisional 21 ballot according to the procedure set out in § 7-5-306(b). The ballot shall 22 be separated and held apart from other provisional ballots east by those not 23 affected by the order. 24 25 SECTION 12. Arkansas Code § 7-5-413(c), concerning voting machine 26 duties, is amended to read as follows: 27 (c)(1) At the time designated by law for the closing of the polls on 28 election day in the notice of election, a set of election officials for the 29 machines used for early voting shall canvass the vote in the manner provided 30 for regular polling sites. After the canvass has been made, the machines 31 shall be secured and shall remain inaccessible to voting. 32 The results of the canvass shall be returned to the county

board of election commissioners to be tabulated and canvassed with and in the

same manner as the returns of other election precincts.

- 1 SECTION 13. Arkansas Code § 7-7-103(b), concerning filing as an 2 independent candidate, is amended to read as follows:
- (b)(1)(A) The person shall furnish by 12:00 noon on May 1 of the year in which the election is to be held petitions signed by not less than three percent (3%) of the qualified electors in the county, township, or district in which the person is seeking office, but in no event shall more than two thousand (2,000) signatures be required for a district, county, or township office.
- 9 (B) If the person is a candidate for state office or for 10 United States Senator in which a statewide race is required, the person shall 11 file petitions signed by not less than three percent (3%) of the qualified 12 electors of the state or which contain ten thousand (10,000) signatures of 13 qualified electors, whichever is the lesser.
  - (2) Each elector signing the petition shall be a registered voter, and the petition shall be directed to the official with whom the person is required by law to file nomination certificates the petition to qualify as a candidate and shall request that the name of the person be placed on the ballot for election to the office mentioned in the petition.
  - (3) Petitions shall be circulated not earlier than sixty (60) calendar days prior to the deadline for filing petitions to qualify as an independent candidate.
    - (4) In determining the number of qualified electors in any county, township, or district or in the state, the total number of votes cast therein for all candidates in the preceding general election for the office of Governor shall be conclusive of the number of qualified electors therein for the purposes of this section.

- 30 (c)(1) Party pledges, if any, shall be filed and any filing fees of a 31 political party, if any, shall be paid during regular office hours in the 32 period beginning at 12:00 noon on the third Tuesday in March and ending at 33 12:00 noon on the fourteenth day thereafter before the preferential primary 34 election.
  - (2) A party certificate and the political practice pledge for primary elections shall be filed with the county clerk or the Secretary of

- 18 (b) If any candidate, either prior to the certification of the ballot
- 19 for the preferential primary or subsequent to the preferential primary but
- 20 prior to the certification of the ballot for the general primary election,
- 21 shall notify the secretary of the state committee in the case of a United
- 22 States, state, or district office or the secretary of the county committee in
- 23 the case of a county, city, or township office, in writing, signed by the
- 24 candidate and acknowledged before an officer authorized by law to take
- 25 acknowledgments, of his or her desire to withdraw as a candidate for the
- 26 office or position, then the committee shall immediately notify the county
- 27 board of election commissioners or the State Board of Election Commissioners
- 28 Secretary of State, as the case may be, and the name of the person shall not
- 29 be printed on the preferential primary ballot or the general primary ballot,

- 18 and the order in which issues and measures are to appear on the ballots at
- 19 all preferential and general primary elections shall be determined by lot at
- 20 the public meeting of the county <del>committee</del> <u>board of election commissioners</u>
- 21 held not later than thirty-five (35) days before the preferential primary
- 22 election. Ten The county board shall give ten (10) days' written notice of
- 23 the time and place of the meeting shall be given each member by to the chair,

- 25 or secretary shall publish notice of the time and place of holding the

- (7) Request the voter, in the presence of the election official, to sign his name, including his given name, his middle name or initial, if any, and his last name in the space provided on the precinct voter registration list. If a person is unable to sign his signature or make his mark or cross, the election official shall enter his initials and the voter's date of birth in the space for the person's signature on the precinct voter registration list; and
- 28 (8) Record the voter's name on or request the voter to print his 29 or her name on the list of voters form.
  - (b) At the same time that the voter identifies himself and the party primary or other election in which he or she intends to vote, the election official of the party primary which the voter designates shall mark next to the voter's name on the precinct voter registration list furnished by the county clerk as having voted the party primary or other election in which the voter chooses to vote.
    - (c) If a voter's name does not appear on the precinct voter

- 1 registration list, the election official shall permit the voter to vote only 2 under the following conditions:
- 3 (1) The voter identifies himself by stating his name and date of 4 birth and is verified by the county clerk as a registered voter within the 5 county and, if the county is divided into more than one (1) congressional 6 district, within the same congressional district;
- 7 (2) The voter gives and affirms his current residence, and the 8 election official verifies with the county clerk that the voter's residence 9 is within the precinct;
- 10 (3) The voter completes an updated voter registration application form; and
- 12 (4) The voter signs the precinct voter registration list.
- 13 (d) If the voter is not listed on the precinct voter registration list
  14 and the county clerk is unable to verify the voter's registration but the
  15 voter contends that he or she is eligible to vote, then the voter may vote a
  16 provisional ballot which shall only be counted upon verification of the
  17 voter's registration status.
- 18 (e) The election officials shall make and retain a <u>separate</u> list of 19 all voters who cast a provisional ballot.
- 20 (f) After the polls close, the election official shall total the 21 number of voters on the list of voters form.

The county board of election commissioners shall canvass the returns and examine the ballots when demanded. It may hear testimony, if offered, of fraudulent practices and illegal votes, may cast out illegal votes and fraudulent returns, may find the true and legal vote cast for each candidate, and it shall certify the result not sooner than forty-eight (48) hours and not later than ten (10) days after the primary.

34 SECTION 19. Arkansas Code § 7-9-305 is amended to read as follows: 35 7-9-305. Election and certification of delegates.

(a) The county board of election commissioners shall include on the

- general election ballots the names of all candidates for delegate to the constitutional convention as certified by the Secretary of State.
  - (b)(1) The candidate receiving a majority of the votes for a particular position in the general election shall be declared elected as a delegate to the convention.
  - (2) In the event that more than two (2) candidates are seeking a particular delegate position and that no candidate receives a majority of the votes cast for all candidates for the position, the names of the two (2) candidates receiving the highest number of votes for the position shall be certified to a special runoff election which shall be held by the respective county board of election commissioners of the district two (2) three (3) weeks from the day on which the general election is held. The special runoff election shall be conducted in the same manner as is now provided by law, and the election results shall be canvassed and certified in the manner provided by law.
  - (3) A tie vote for a delegate position in the special runoff election shall be determined by drawing lots in the presence of the circuit court of the county within ten (10) days from the date of the election.
  - (c) The results of the election of delegates at the general election, or at a special runoff election held for delegate positions, shall be certified to the Secretary of State along with the other election results as is now provided by law.

- SECTION 20. Arkansas Code § 7-10-102(b)(2), concerning nonpartisan elections of judges and justices, is amended to read as follows:
- (2) The names of candidates for nonpartisan judicial offices shall be included on the ballots of the political parties and shall be designated as nonpartisan judicial candidates. However, separate ballots containing only the names of nonpartisan judicial candidates shall be prepared and shall be made available to voters requesting the same.

- 32 SECTION 21. Arkansas Code § 14-42-206 is amended to read as follows: 33 14-42-206. Municipal primary elections - Nominating petitions.
