28 the Arkansas Army National Guard, the Arkansas Air National Guard, the United  
29 States Air Force Reserve in Arkansas, the United States Army Reserve in  
30 Arkansas, the United States Navy Reserve in Arkansas, and the United States  
31 Marine Corps Reserve in Arkansas; and

33 WHEREAS, the Arkansas Reserve Components Emergency Relief Fund is a  
34 nonprofit association that provides financial assistance to the members and  
35 families of the Arkansas National Guard and Reserves during periods of long-  
36 term deployment operations; and
