20	THE PRIVACY AND CIVIL LIBERTY CONCERNS
21	OF THE REAL ID ACT OF 2005.

24	WHEREAS, in May 2005, the United States Congress enacted the Real ID
25	Act of 2005 as part of the Emergency Supplemental Appropriations for Defense,
26	the Global War on Terror, and the Tsunami Relief Act, Pub. L. No. 109-13,
27	which was signed by President Bush on May 11, 2005, and which becomes
28	effective on May 11, 2008; and
29	
30	WHEREAS, the costly and controversial provisions in the Real ID Act of
31	2005 relate to the implementation of national driver's license standards; and
32	
33	WHEREAS, the critics of the Real ID Act of 2005 contend that the
34 25	implementation of national driver's license standards is an unfunded federal
35	mandate, intrudes upon the states' sovereign power to determine state
36	policies for identification, licensure, and credentialing of their residents,

1 and is cause for constitutional concerns regarding invasion of privacy ; and
2

3 WHEREAS, according to a recent survey of forty-seven (47) state 4 licensing authorities conducted by the National Governor's Association, the 5 National Conference of State Legislatures, and the American Association of 6 Motor Vehicle Administrators, the REAL ID Act of 2005 will cost the states 7 over eleven billion dollars (\$11,000,000,000) to implement; and

- 9 WHEREAS, the critics of the Real ID Act of 2005 include the National 10 Governor's Association, National Conference of State Legislatures, and 11 American Association of Motor Vehicle Administrators, and the critics also 12 predict state compliance with the provisions of the REAL ID Act of 2005 will require all of the estimated two hundred forty-five million (245,000,000) 13 14 current driver license and identification card holders in the United States 15 to renew their current identity documents in person by producing three (3) or 16 four (4) identity documents, thereby increasing processing time and doubling 17 wait time at licensing centers; and

WHEREAS, the "common machine-readable technology" required by the REAL ID Act of 20005 would convert state-issued driver licenses and identification cards into tracking devices, allowing computers to note and record a person's whereabouts each time they are identified; and

WHEREAS, the requirement that states maintain databases of information about their citizens and residents and then share this personal information with all other states will expose every state to the information security weaknesses of every other state and threaten the privacy of every American; and

WHEREAS, identification-based security provides only limited security benefits because it can be avoided by defrauding or corrupting card issuers and because it gives no protection against people not already known to be planning or committing wrongful acts; and

35 WHEREAS, a more secure and flexible system of verifying identity may be 36 achieved by less intrusive means to the individual and to states by employing

the free market and private sector ingenuity; and WHEREAS, on March 1, 2007, the White House moved back a deadline to implement the national driver's license standards which will allow these issues to be addressed, NOW THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN: THAT the Arkansas General Assembly urges the United States Congress and the United States Department of Homeland Security to re-examine the scope and costs of the mandates placed on states under the Real ID Act of 2005 and seek the necessary input from states on all issues related to national driver's license standards. BE IT FURTHER RESOLVED THAT the Arkansas General Assembly urges the United States Congress and the United States Department of Homeland Security to add critical privacy and civil liberties safeguards to the REAL ID Act of 2005 to avoid the significant problems it currently poses individual liberties to which each citizen of the United States is entitled. BE IT FURTHER RESOLVED THAT a copy of this resolution be sent to the Majority Leader of the United States Senate, the Speaker of the United States House of Representatives, and the members of Arkansas's congressional delegation.
