2 The clerks of the circuit courts shall be elected by the qualified electors of the several counties for the term of two four (4) years, and 3 4 shall be ex-officio clerks of the county and probate courts and recorder; provided, that in any county having a population exceeding fifteen thousand 5 6 inhabitants, as shown by the last Federal census, there shall be elected may 7 elect a county clerk, in like manner as the clerk of the circuit court, for 8 the term of four (4) years, and in such case the county clerk shall be ex-9 officio <del>clerk of the probate court</del> Clerk of the Probate Court of such county until otherwise provided by the General Assembly. 10 11 SECTION 2. Section 29 of Article 7 of the Arkansas Constitution is 12 amended to read as follows: 13 14 § 29. County judge - Election - Term - Qualifications. 15 The Judge of the County Court shall be elected by the qualified 16 electors of the county for the term of  $\frac{1}{100}$  four (4) years. He shall be at 17 least twenty-five years of age, a citizen of the United States, a man of upright character, of good business education, and a resident of the State 18 19 for two years before his election; and a resident of the county at the time of his election, and during his continuance in office. 20 21 22 SECTION 3. Section 46 of Article 7 of the Arkansas Constitution 23 is amended to read as follows: 24 § 46. County executive officers - Compensation of county assessor. The 25 qualified electors of each county shall elect one Sheriff, who shall be ex-26 officio collector of taxes, unless otherwise provided by law; one Assessor, 27 one Coroner, one Treasurer, who shall be ex-officio treasurer of the common 28 school fund of the county, and one County Surveyor; for the term of two four (4) years, with such duties as are now or may be prescribed by law: Provided, 29 30 that no per centum shall ever be paid to assessors upon the valuation or assessment of property by them. 31 32

33 SECTION 4. Amendment 41 of the Arkansas Constitution is amended to 34 read as follows:

35 Election of county clerk.

36 The provisions for the election of a County Clerk upon a population

1	basis are hereby abolished and there may be elected a County Clerk in like
2	manner as a Circuit Clerk, for the term of four (4) years, and in such cases,
3	the County Clerk may be ex officio Clerk of the Probate Court of such county
4	until otherwise provided by the General Assembly.
