27	Arkansas; and

30	scholarship funds to pay tuition and mandatory fees for up to five (5) years
31	of study at any accredited university or community college in the country,
32	dependent upon the length of time the student has attended El Dorado public
33	schools; and

35	WHEREAS, the El Dorado Promise is funded up to fifty million dollars
36	(\$50,000,000) for twenty (20) years and may be extended at the end of twenty

     university; and is based on length of attendance in El Dorado public schools,

     with graduates who attend all schooling in El Dorado public schools to

     receive one hundred percent (100%) of the scholarship; and

     accredited two-year or four-year college or university in the United States;

     progress toward a bachelor's degree or an associate degree; maintenance of a
