19 WHEREAS, the Murphy Oil Corporation has established and funded the El
20 Dorado Promise scholarship program for El Dorado high school students to
21 pursue higher educational opportunities; and

23 WHEREAS, the Murphy Oil Corporation has committed five million dollars
24 a year for the next ten years to fund the program; and

25
26 WHEREAS, the El Dorado Promise provides up to five years of tuition and
27 mandatory fees for undergraduate post-secondary education for students
28 entering college immediately following high school; and

29
30 WHEREAS, the tuition scholarship program can be used to pursue an
31 associate degree or bachelor's degree at any public or private college either
32 in Arkansas or out of state; and

34 WHEREAS, Claiborne Deming, Murphy Oil's President and Chief Executive
35 Officer commented on the scholarship program, stating that the El Dorado
36 Promise gives students who may have been unable to afford college the



1 opportunity to attend the school of their choice. "We are committed to
2 making El Dorado a great place to live and work, and we created the promise
3 to further invest in El Dorado's greatest resource, our children".; and

5 WHEREAS, Bob Watson, Superintendent of the El Dorado School district
6 noted, "this is a huge day." As of today, El Dorado high school graduates
7 will have unprecedented opportunity to continue their education. For some
8 students, this is life changing. Students who have worked hard, but would
9 not have been able to attend college because of financial limitations now
10 have the means to do so".; and

12 WHEREAS, Murphy Oil integrates corporate citizenship with the company's
13 business goals through community involvement, excellence in education,
14 relationship building, charitable contributions, and external partnerships,
