29	SECTION 1. Arkans	as Code Title 17, Chapter 82, Subchapter 1 is ame	nded
30	to add an additional section to read as follows:		
31	17-82-110. Legend	drugs.	
32	(a) As used in th	is section, "dispensing dentist" means a dentist	
33	licensed under this chapter who purchases legend drugs to be dispensed to his		
34	or her patients for the patients' personal use and administration outside the		
35	dentist's office.		
36	(b) A dispensing dentist shall:		

1	(1)(A) Personally dispense legend drugs; and		
2	(B) The dispensing of the legend drugs shall not be		
3	delegated;		
4	(2)(A) Keep records of all receipts and distributions of legend		
5	drugs.		
6	(B) The records shall be:		
7	(i) Subject to inspection by the proper enforcement		
8	authority;		
9	(ii) Readily accessible for inspection; and		
10	(iii) Maintained in a central registry; and		
11	(3) Comply with the rules adopted by the Arkansas State Board of		
12	Dental Examiners to regulate the dispensing of legend drugs;		
13	(4) Label legend drugs with the following information:		
14	(A) Patient's name and address;		
15	(B) Dispensing dentist's address and narcotic registry		
16	number issued by the Drug Enforcement Administration of the United States		
17	Department of Justice;		
18	(C) Date of dispensing; and		
19	(D) Directions and cautionary statements, if any, as		
20	required by law.		
21	(d)(1) No dentist licensed under this chapter shall dispense legend		
22	drugs without prior approval by the board and receipt of a permit from the		
23	board authorizing the dispensing of specific legend drugs.		
24	(2) The dentist shall apply to the board for the dispensing		
25	permit on forms the board authorizes.		
26	(3) The board shall issue a permit upon a finding by the board		
27	that the dentist has shown a need for the permit for dispensing the specific		
28	legend drugs the dentist has requested.		
29	(e) The board shall enforce this section and shall adopt rules to		
30	carry out its purpose.		
31	(f) The board shall charge an annual fee for the issuance of		
32	dispensing permits:		
33	(1) To cover the costs of administering this section; and		
34	(2) Ensure that the health and safety of the citizens of		
35	Arkansas are protected and that dispensing dentists are in compliance with		
36	the law and with the rules of the board.
